Joint resolution accepting revenue from the Ann and Robert H. Lurie Children's Hospital of Chicago and authorizing an emergency appropriation in the amount of \$26,000.

- The Coroner's Office has an agreement to participate in the development of the State Unintentional Drug Overdose Reporting System (SUDORS).
- The Lake County Coroner's Office has been notified of reimbursement in the amount of \$26,000 for participation in this system, which was unbudgeted.
- The Coroner's Offices wishes to utilize this revenue to purchase mobile cadaver trays and related equipment for the Coroner's Office.

Joint resolution amending rates for the Lake County Sheriff Deputies working off duty "Special Detail" for private business, individuals, and government units.

- The hourly rate charged to private businesses, individuals, and governmental units for special detail patrol has been \$63 per hour since July 1, 2015.
- The rates for employees performing patrol and command duties while on special detail has been \$41 and \$44.80 per hour, respectively, since July 1, 2015.
- The Sheriff is requesting to increase the special detail rate charged to private business, individuals and governmental units to a corresponding amount of \$70 per hour and \$76 per hour if the special detail requests a command officer; effective May 1, 2020.
- All related costs, including administrative cost, will be recovered from the

organization requesting the service and any fines and forfeitures for any violations will be paid to the County.

- General engineering and support services are needed to supplement in-house design services and improve the County highway system.

- Lake County and the Village of Libertyville entered into an agreement dated July 9, 1991, for maintenance of a portion of the North Shore Bike Path.
- Lake County and the Village of Libertyville are desirous of entering into a new updated agreement which more clearly defines maintenance responsibilities and limits of maintenance for a portion of said North Shore Bike Path.
- The Village will continue to be responsible for routine maintenance such as mowing and pothole patching.
- Lake County will continue to be responsible for capital maintenance such as pavement rehabilitation and repairs to the drainage system.
- The Village of Libertyville Board of Trustees will approve this agreement at a future board meeting.

Joint resolution appropriating \$50,000 of Motor Fuel Tax funds for the 2020 repair and replacement of various guardrail and fence installations, under the applicable Illinois Highway Code.

- The County owns miles of guardrails and fences along the County highway system, and annual repairs and replacements must be made to various installations which are included in the highway improvement program, and designated as Section 20-00000-06-GM.
- Before the purchase of material or a contract service can be procured, an appropriation of \$50,000 of Motor Fuel Tax funds is required.

Joint resolution appropriating \$141,200 of Matching Tax funds for inspection and maintenance of recently planted native landscape areas along various County highways.

- The County has planted native landscape areas for various projects on the County highway system that require routine inspection and maintenance, and designated as Section 20-00000-14-GM.
- This maintenance will be done by a contractor.
- Before a project letting can be held, an appropriation of \$141,200 of Matching Tax funds is needed.

Joint resolution authorizing an agreement with Jorgensen and Associates, Inc., Lake Villa, Illinois, for land surveying services to support the design of improvements to Deep Lake Road, from Grass Lake Road to Depot Street, at a maximum cost of \$52,814, and appropriating \$65,000 of Motor Fuel Tax funds.

- Deep Lake Road, from Grass Lake Road to Depot Street, will be resurfaced.
- In addition to the resurfacing work, this improvement will include guardrail replacement, culvert replacement, improved drainage, and installation of bike-friendly shoulders.
- A consultant will be utilized to provide professional land surveying services to

support the in-house design engineering work for the Deep Lake Road project.

- Lake County selects professional land surveying firms in accordance with the Local Government Professional Services Selection Act, 50 ILCS 510/1 et. seq.
- The Lake County Division of Transportation Professional Services Selection process has been approved by the Federal Highway Administration and the Illinois Department of Transportation, and the firm selected for this project was selected in accordance with this approved process.
- Public notices were published on March 29 and April 2, 2019, resulting in 11 firms submitting Statements of Interest and Statements of Qualifications. Three firms were shortlisted and interviewed on May 2, 2019.
- This resurfacing improvement has been identified within the County's pavement management system, is included in the highway improvement program with target construction in 2021, and designated as Section 19-00999-66-RS.

28 [19-1743](#)

Ordinance amending Chapter 51 of the Lake County Code of Ordinance, sewer-related rates for certain Lake County systems by making modifications to previously approved rates.

- The Rate Ordinance establishes all water and sewer user rates and connection fees for the County's water and sewer systems and is reviewed annually or as needed.
- On August 13, 2019, the County Board approved an amendment to the Rate Ordinance based on the results of a recently conducted water and sewer rate and connection fee study.
- The study applied an increase of 4.1 percent to all sewer rates for metered, unmetered and wholesale usage.
- The increase was inadvertently applied to the portion of the sewer rate that is collected by Lake County Public Works but charged by third-party treatment providers and needs to be amended.
- This Ordinance modification also makes one technical correction in the previously approved 2019 Rate Ordinance by including the initial permit fee of \$200 with an annual renewal fee of \$100 for the discharge of septage and holding tank waste in the wastewater system.
- Notice will be provided to the County's municipal partners impacted by the changes.

Joint resolution authorizing a contract with Openedge, Lindon, Utah, to provide credit card and e-check processing services for the Lake County Public Works Department's Tyler Incode 10 utility billing software at a current estimated annual

cost of \$102,145.

- Due to technological advances and enhanced security requirements a replacement utility billing system was necessary, and on July 10, 2018 the County Board awarded Tyler Technologies a contract to implement Incode 10 as the Public Works department's new billing software system.
- The department needs to utilize a payment processor that will maintain the same level of service options for its customers including electronic credit card and e-check payments. The department's current credit card processor will not integrate with the Tyler product.
- Openedge is the only source that can provide electronic credit card and e-check payments that directly integrates with the Tyler Incode 10 software.
- The Department is unable to move forward with the anticipated year end 2019 system implementation until the new credit card processor is selected.
- Pursuant to Article 6, Section 102 of the Lake County Purchasing Ordinance, the Purchasing Agent approved the bid exemption on the basis that there is only one source for the required goods, service, or construction item.
- This authorizes the Purchasing Agent to execute an agreement with Openedge to provide electronic credit card and e-check processing services for the Tyler Incode 10 utility billing software at a current estimated annual cost of \$102,145.

- Lake County Public Works is seeking engineering services for water system modelling and capacity analysis. This master agreement, sourced through a full Statement of Interest (SOI) competitive process, will allow individual task orders to be issued up to a maximum cumulative value of \$200,000 for a given year. The term of the contract will be two years with three one-year renewal options to allow for future projects with services based on approved contracted rates.
- Vernon Hills and Knollwood Rondout Water Models is the initial project to be completed under this agreement.

- Lake County Public Works is seeking underground utility design engineering consulting services. This master agreement, sourced through a full Statement of Interest (SOI) competitive process, will allow individual task orders to be issued up to a maximum cumulative value of \$325,000 for a given year. - Lake County Public Works provides sewer service throughout portions of Lake County and undertakes cleaning and televising of sanitary sewer systems.
- As part of the County's shared services initiative, Public Works has been working closely with the County Administrator's Office to identify shared service opportunities.
- Pursuant to Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake County may participate in a cooperative purchasing agreement for the procurement of goods with one or more public procurement units in accordance with an agreement entered into between the participants.
- RHMG, on behalf of the Northwest Lake Facility Planning Areas (FPA) wholesale advisory committee prepared bid documents for Fiscal Year 2019 Sanitary Sewer Cleaning and Televising Program.

Resolution authorizing a contract with Johnson Controls, Arlington Heights, Illinois, for Building Automation Systems (BAS) upgrades to the Center Courts in the amount of \$31,429.26.

- As part of Fiscal Year 2019 Budget Process, services were approved to retrofit the original air handler equipment with a variable speed drive to improve efficiency and decrease overall costs.
- This work will install and commission five wireless thermostats and occupancy sensors in the courtrooms, as well as, the secure hallways adjacent to the Judge's chambers on all four floors in the Center Courts facility. that will have a term of 25 years. The County will not own the solar panels but will be responsible for the operation and maintenance of each system and through this contract will delegate the tasks to WCP Solar.

- The final electrical rate for the solar panels will be calculated based on a series of criteria. The final rates will be brought back to the Committee in the form of a contract modification.
- A buyout provision is included in the Agreement for each site should the County elect to purchase the system in either the eighth or fifteenth year of the Agreement.
