Joint resolution appropriating \$230,000 of ¼% Sales Tax for Transportation funds for the Joint Utility Locating Information for Excavators, Inc. (JULIE) annual message handling services fee, and extending a contract with Utility Resource Group, LLC, Sterling Heights, Michigan, to locate Lake County Division of Transportation's (LCDOT) storm sewers for excavator dig requests for various County highways.

- Pursuant to Illinois law, JULIE serves as a message handling notification service for underground facility owners regarding planned excavations.
- LCDOT's existing storm sewer locating contract with Utility Resource Group, LLC began on March 1, 2016, and allows a total of four one-year contract extensions. This will be the fourth one-year contract extension and will cover the period of March 1, 2020, to February 28, 2021.

Resolution naming new roadways and renaming existing roadways in conjunction with the realignment of U.S. Route 45 at the Millburn Road/Grass Lake Road intersection in the vicinity of the Millburn Historic District (Millburn Bypass).

- The Millburn Bypass project created two remnant roadway segments, old U.S. Route 45, from the realigned U.S. Route 45 north to the newly constructed cul-de-sac, and old Grass Lake Road, from old U.S. Route 45 west to the newly constructed cul-de-sac.

- At its January 16, 2018 meeting, the County Board approved the jurisdictional transfer of old U.S. Route 45, in its entirety, from the State of Illinois to Lake County.
- It is desirous to rename these remnant roadway segments to better facilitate wayfinding in the area.
- It is recommended that old U.S. Route 45 be renamed as Main Street, and that old Grass Lake Road be renamed as Old Town Court.
- The Millburn Bypass project also constructed a new roadway segment between old U.S. Route 45 and the realigned U.S. Route 45 that will align Millburn Road and Grass Lake Road.
- This new roadway extension needs to be named and added to the County highway system.
- It is recommended this new roadway extension be added to County highway system as County Highway 14 and be named Millburn Road.
- The notification process will begin upon approval by the County Board.
- The name changes are planned to take place in early 2020.

Joint resolution approving Change Order Number One consisting of an increase of \$77,682 and appropriating a supplemental amount of \$55,000 of ¼% Sales Tax funds for additional Phase II engineering services for the intersection improvement of Miller Road at US Route 12.

- Miller Road, County Highway 2, at US Route 12 will be improved by adding turn lanes and modifying the traffic signal.

Joint resolution authorizing two agreements with Pace Suburban Bus Division of the Regional Transportation Authority (RTA) providing terms and conditions for the year 2020 by which Pace will continue to coordinate operations of, and partially fund, the Ride Lake County West and the Ride Lake County Central Coordinated Transportation Services in the Townships of Antioch, Avon, Fremont, Grant, Lake Villa, Libertyville, Shields, and Wauconda, also the Villages of Libertyville and Mundelein.

- Beginning in 2009, Lake County entered into yearly agreements with Pace for paratransit services in support of the Lake County Coordinated Transportation

Services Committee (LCCTSC).

- The County has two agreements with Pace: a subsidy agreement that expired December 31, 2019, and an intergovernmental agreement that will expire on February 29, 2020.
- The two new agreements are for Pace to operate paratransit services for the Ride Lake County West Service and the Ride Lake County Central Service and for Pace to reimburse the County a portion of the grant's local match for the Ride Lake County West Service and a portion of service costs for the Ride Lake County Central Service in 2020.
- Pace will provide 25 percent of the local match to the grant funds, up to \$100,000, for the Ride Lake County West Service, and \$6,361 for the Ride Lake County Central Service.

Joint resolution approving an Intergovernmental Agreement with the Village of Hainesville (Village) for access to the County's Land Management System, Tyler Energov.

- The Village has a need for a new permitting system for use within the Village to track and manage their building permits and inspections, code enforcement, and licensing.
- Lake County is currently using Tyler Energov as our land management permit, inspection, code enforcement, and licensing system across its five land departments. During contract negotiations for the system, the County was successful in achieving shared services language within our contract, allowing other municipalities to share the cloud-based solution with other municipalities in Lake County. Licensing of the system is being offered at Tyler's current rates offered to Villages of size similar to Hainesville.
- The County has an executed intergovernmental agreement with the Village for building inspection and development review.

Ordinance amending Chapter 51 of the Lake County Code of Ordinances (water and sewer-related rates for certain Lake County systems) to adjust for a third-party pass-through rate increase to the previously approved ordinance.

- Chapter 51 of the Lake County Code of Ordinances establishes all water and sewer user rates and connection fees for the County's water and sewer systems and is reviewed annually or as needed.
- Under the terms of the agreement between the County and the Village of Libertyville, the Village can adjust wastewater treatment plant charges to the County when there is a rate adjustment for Village users.
- The Village of Libertyville has notified the County of a wholesale sewer increase that will take effect May 1, 2020 and affect all users of the treatment facility including users within the Village of Green Oaks. The Village of Green Oaks has been provided notice of the increase.
- The wholesale sewer rates charged to the County and the Green Oaks sewer rates have been increased in the ordinance.

Resolution to impose a one-year moratorium on recreational cannabis businesses in unincorporated Lake County.

- The Cannabis Regulation and Tax Act, adopted on June 25, 2019, allows for the establishment of recreational cannabis businesses in Illinois and the adult sale and consumption of recreational cannabis products within the State as of January 1, 2020. The Act authorizes local governments (including counties) to enact "reasonable zoning regulations" to mitigate any impacts from recreational cannabis businesses, and alternatively to ban such businesses.
- In order to properly study and consider potential community impacts, it is reasonable to allow additional time for collection and analysis of relevant information prior to making a decision to permit or ban recreational cannabis businesses in unincorporated Lake County.
- Based on direction received from the Public Works, Planning and Transportation Committee on January 8, 2020, the Planning, Building and Development Department has prepared a resolution enacting a moratorium on all Recreational Cannabis Business Establishments in the unincorporated area of Lake County for a period not to exceed one year.
