Joint resolution accepting the 2020 National Crime Victims' Rights Week (NCVRW) Community Awareness Project sub-grant and authorizing an emergency appropriation in the amount of \$5,000.

- Since 1981, NCVRW has been annually observed in April and is intended to increase public awareness and knowledge about the wide range of rights and services available to people who have been victimized by crime.

- The 2020 NCVRW theme is "Seek Justice Ensure Victims' Rights Inspire Hope."
- The program funds will be used during the 2020 NCVRW, April 19-25, to promote community awareness of crime victims' rights and services and will support the purchase of NCVRW event supplies, speaker and announcements.
- The source of program funding is 100 percent federal VOCA; no match is required.

- Change Order Number One, in the amount of \$9,524.14, was needed to add wetland services to the original contract.
- The sum of all change orders is \$111,349.18 and the total revised contract amount is \$424,408.94.

Joint resolution authorizing an emergency appropriation in the amount of \$26,118.10 within the Lake County Public Works Department's Fund 620 for the Northern Lake

County Lake Michigan Water Planning Group's (NLCLMWPG) activities occurring May 1, 2020 through April 30, 2021.

- NLCLMWPG was established by the County, Lake Villa, and Lindenhurst to plan and coordinate efforts to extend Lake Michigan water to northern Lake County.
- The group meets monthly to discuss items associated with the Central Lake County Joint Action Water Agency (CLCJAWA) water system extension project and Special Service Area Number 16 (SSA #16).
- The County serves as the repository and executor of the group's funds and financial transactions.
- On March 27, 2020 the NLCLMWPG approved an annual budget of \$26,118.10 for May 1, 2020 through April 30, 2021. The budget is not appropriated as part of the county's normal budget cycle; therefore, an emergency appropriation is required.

Resolution providing for the establishment of a Special Committee focused on COVID-19 recovery and relief, and appointments to said committee.

LAW AND JUDICIAL COMMITTEE

34 <u>20-0580</u>

Joint resolution authorizing an emergency appropriation and approving a Title IV-D Intergovernmental Agreement (IGA) between the Illinois Department of Healthcare and Family Services (IDHFS) and the Lake County State's Attorney for the continuation of the State's Attorney's Child Support Enforcement Program for the period of July 1, 2020 through June 30, 2025, for a maximum reimbursement amount of \$3,491,909 for staff wages and benefits.

- Since 1985, the State's Attorney's Office has entered into an annual Intergovernmental Agreement with the Illinois Department of Healthcare and Family Services (IDHFS) to provide child support enforcement services.
- Pursuant to these annual agreements, the State's Attorney's Office is to be reimbursed for reasonable costs for providing these services, as determined by IFHS. From 1999 to 2017, the State's Attorney's Child Support Enforcement (CSE) staff included three assistant state's attorneys, four secretaries, three paralegals and one investigator.
- Currently, the CSE staff includes two full-time assistant state's attorneys, a .5 full-time equivalent (FTE) assistant state's attorney/supervisor, three full-time legal assistants, and 2.75 FTE paralegals.
- The Child Support Enforcement Division handles approximately 12,000 active cases, including those to establish paternity, to set support upon voluntary acknowledgement, to establish medical support orders, and to enforce orders for payment of support.
- IDHFS has tendered a proposed Five-Year Contract for 2021-2025 to reimburse

personnel costs not to exceed \$3,491,909, 66 percent of which is federal funds.

- Funding for the 2021 Lake County contract will be increased from \$610,000 to \$671,000, with remaining years 2022 \$684,420, 2023 \$698,108, 2024 \$712,070, and 2025 \$726,311.
- Fiscal Year 2020 Program cost is \$899,072 which includes: \$671,000 from the State of IDHFS and \$228,072 in the State's Attorney's current operating budget.

35 <u>20-0310</u>

Joint resolution amending the Lake County Health Department Environmental Health Fees Schedule (as authorized in Lake County Code of Ordinances Chapter 178)

- The Environmental Health Water Well program is proposing revisions to fees associated with non-community water systems.
 - The proposed fee revisions relieve facilities from having to pay potentially high lab costs for repeat samples, reduce the time and cost of billing for repeat and monthly samples for Health Department staff, and eliminate the need for monthly-sampled facilities to pay monthly invoices during the year.
 - The proposal, if implemented, will be revenue neutral.
- This proposal would eliminate charging and invoicing for repeat sample fees, and would offset the revenue by slightly increasing the annual permit fee for all facilities.
 - With a projected two percent CPI for Fiscal Year (FY) 2021, the cost of an annual permit in 2021 would be \$218 without this change.
 - This proposal would increase the FY 2021 fee by \$22 to \$240, or around 10 percent.
 - But no facility, with the exception of those who have neglected to take documented, mandated actions to correct a system deficiency would ever be responsible for additional collection and analysis fees.
- The proposal also creates two new fees that would allow the option for monthly-sampled facilities to pay for the samples in one payment at the start of the year, along with their permit fee.
 - Potentially affected facilities were contacted and are in favor of this proposal.
- The Board of Health met regarding this item on February 26, 2020.

- The \$100,000 Anonymous Foundation donation will be used to purchase necessary personal protective equipment.
- The \$100,000 in additional funding has not been previously appropriated because the resources were secured after the County's adoption of the Fiscal Year (FY)

2020 budget.

Joint resolution amending County Board resolution 20-0503 (adopted on April 7, 2020) to allow the County's \$100,000 agency unreimbursed novel coronavirus (COVID-19) emergency shelter funds (derived from 2020 Video Gaming Revenue) to be utilized for Alternate Housing Sites.

- On April 7, 2020, the County Board adopted a resolution authorizing \$100,000 in 2020 Video Gaming Revenue to be reserved for agencies providing emergency shelter for people who are homeless during the COVID-19 crisis.
- The original resolution was predicated upon the community need for emergency non-congregate homeless shelter as a safer alternative to congregate sheltering during the COVID-19 pandemic. Due to the widespread impact of the COVID-19 pandemic on local health and human services, additional non-congregate emergency shelter needs are anticipated.
- The use of funds, reserved from 2020 Video Gaming Revenue, under the original resolution was to "fund or reimburse emergency, non-congregate shelter needs including, but not limited to, reimbursing Lake County shelters for costs of emergency, non-congregate shelter" in the event that adequate funding or reimbursements from other sources are not available.
- Since the adoption of the original resolution, additional federal funding sources have been identified to reimburse non-congregate shelter costs of Lake County's homeless shelter organizations, including pandemic-related Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funding under the 2020 Cares Act.
- Simultaneously, the need for emergency non-congregate sheltering at Health Department-managed Alternate Housing Sites will continue to increase for (a) persons who test positive for COVID-19 who do not require hospitalization but need isolation; (b) persons who have been exposed to COVID-19 and do not require hospitalization; and (c) asymptomatic high-risk persons needing social distancing as a precautionary measure, such as people over 65 or with certain underlying health conditions. County up-front expenses for Alternate Housing Sites may be partially reimbursable under FEMA's Public Assistance Program.
- Lake County's homeless shelter agencies that currently house clients in non-congregate shelter may have a need to divert those clients that meet criteria (a) or (b) above to a Health Department-managed Alternate Housing Site; funding will be needed to allow the diversion of such clients to Alternate Housing Sites.
- Given the availability of other sources for reimbursing Lake County's homeless shelter organizations, and the growing need for County expense of funds to shelter persons (including homeless individuals who are COVID-19 positive or exposed) at Alternate Housing Sites, this resolution amends the original resolution to allow the use of the County's \$100,000 agency unreimbursed novel corona virus (COVID-19) emergency shelter funds (derived from 2020 Video Gaming Revenue) to be utilized for Alternate Housing Sites.

38 <u>20-0597</u>

Joint resolution approving the second amendment to the 2019 United States Housing and Urban Development (HUD) Annual Action Plan (AAP).

- The CARES Act was signed into law on March 27, 2020 to alleviate the immediate needs related to the COVID-19 pandemic. The CARES Act includes up to \$5,000,000,000 in Community Development Block Grant (CDBG) funding and \$4,000,000,000 of Emergency Solutions Grant (ESG) funding.
- As an entitlement community Lake County will receive an additional \$1,709,120 of CDBG and \$777,472 of ESG funds from the first allotment of this funding.
- HUD requires the submission of an Annual Action Plan (AAP) and associated amendments to govern expenditure of federal housing and community development funding for each program year.
- The Second Amendment to the Program Year 2019 (PY 2019) Annual Action Plan (AAP) incorporates the CARES Act funding and allocates \$777,472 of ESG funds to support shelter, rapid rehousing and program administration. The amendment also includes \$1,591,824 of CDBG funds to support: rental assistance, legal services, housing counseling, food banks, emergency small business loans and program administration.
- The Second Amendment to the PY 2019 Annual Action Plan (AAP) reallocates \$88,732 in 2019 HOME funds approved for the Community Partners for Affordable Housing (CPAH) Owner Occupied Rehabilitation Program (OORP) to the CPAH Down-payment Assistance Program (DAP).

Joint resolution authorizing a contract for Permanent Supportive Housing Expansion HOME Tenant-Based Rental Assistance from Thresholds, Chicago, Illinois, in an amount not to exceed \$260,311.

- Community Development worked with consultants at the Corporation for Supportive Housing to develop innovative funding mechanisms for additional permanent supportive housing (PSH) units for Lake County residents experiencing homelessness.
- The County Board approved funding for this purpose in the approved Fiscal Year (FY) 2019 Annual Action Plan.
- Thresholds were selected to receive the contract for rental assistance, administrative costs, and a performance payment as a result of a public call for partners. The performance payment will be dependent upon successful outcomes.
- Pursuant to the Code of Federal Regulations, the participating jurisdiction may select a subrecipient to administer all or some of the participating jurisdiction's HOME programs to provide tenant-based rental assistance. This contract authorizes Thresholds to provide this tenant-based rental assistance in an amount not to exceed of \$260,311 for services through April 30, 2022.

40 <u>20-0312</u>

Resolution authorizing the proposed revisions to Lake County Code of Ordinances Chapter 177, Tobacco Regulations.

- Due to the adoption of the Prevention of Tobacco Use by Persons under 21 Years of Age and Sale and Distribution of Tobacco Products Act (720 ILCS 675/), also known as Tobacco 21, revisions to Chapter 177 need to be made to align the ordinance with the Act.
- The amendments to the Act changed the definition of a "tobacco product" by removing electronic cigarettes and alternative tobacco products, defining each of these items separately.
- To make the correction, the proposed revisions to Chapter 177 strike the current definitions of "tobacco product" and "electronic smoking device," and add the definitions of "tobacco product," "electronic cigarette," and "alternative nicotine product" as defined in the Act.
- Additionally, the term "tobacco products" is replaced with "tobacco products, electronic cigarettes, and (or) alternative nicotine products" throughout the ordinance.
- The Board of Health met regarding this item on February 26, 2020.

An ordinance amending ordinance prohibiting the use of groundwater as a potable water supply by the installation or use of potable water supply wells or by any other method.

- On August 13, 2019, the County Board approved an ordinance to prohibit the use of groundwater from water wells as a potable source of water in designated areas around the Hoffelder closed landfill site in order to allow for development of these properties without further environmental remediation.
- The owner of the property secured similar ordinances from other neighboring jurisdictions.

Ordinance establishing the Lake County Temporary Emergency Public Nuisance Ordinance.

- During the COVID-19 pandemic, based upon available information from the Centers for Disease Control (CDC), people of all ages with underlying respiratory medical conditions, including chronic lung disease and asthma, are at higher risk for developing more serious complications if they contract COVID-19. Smoke from open burning can exacerbate these residents' respiratory conditions and further compromise their ability to fend off potentially severe effects of COVID-19. Additionally, people who do not have underlying conditions can experience more severe COVID-19 symptoms when exposed to smoke from open burning.
- Open burning during the pandemic also increases the potential risk of uncontrolled spread of fire, which could impact fire departments and County, municipal and other local governmental first responders at a time when their resources may be otherwise needed to assist in public health and safety.
- In light of these potential risks, numerous state and local governments throughout the United States have enacted temporary bans on open burning. Several fire protection districts across Lake County encompassing unincorporated areas have likewise enacted temporary bans on open burning within their boundaries.
- Attached as Exhibit A is an Ordinance enacting a temporary prohibition of the open burning in the unincorporated area. This Ordinance would reinforce and support bans already in effect in various fire protection districts throughout Lake County and provide additional means of enforcement over prohibited open burning activity in the unincorporated area.
- This temporary emergency ordinance will go into effect immediately upon County Board adoption of Exhibit A and expire on June 10, 2020.
