The Video Gaming Revenue is invested consistent with the Board-approved policy which prioritizes services related to gambling addiction. Staff released a public application round late November to solicit opportunities to invest in the community. Those applications were reviewed and scored by staff resulting in funding recommendations that were approved by the Human Services Advisory Recommendations Committee and the full Housing and Community Development Commission.

In December 2020, the Lake County Board revised its Video Gaming Revenue Policy to provide ongoing support for 211 through United Way of Lake County in a noncompetitive, multi-year commitment. This year, there is an additional opportunity to invest in 211 through CDBG-CV funding. Between these two funding sources, United Way is recommended for \$160,000 of funding for 211 (only the VGR funding portion therein is reflected in the award list below; the CDBG-CV funding portion for 211 is addressed in a separate agenda item).

The following funding recommendations represent the full amount of Video Gaming Revenue appropriated in the County budget.
