Planning, Building & Development Community Development



- Advises County Board on grants from U.S. Department of Housing & Urban Development (HUD), L.C. Video Gaming Revenue and L.C. Affordable Housing Fund
 - Oversees a five-year community planning process to guide annual funding allocations
 - Staffs the Housing and Community Development Commission
- Works to further Fair Housing Choice
 - Conducts a periodic HUD-required Analysis of Impediments to Fair Housing Choice (Lake County is required to annually certify it affirmatively furthers fair housing)
- Liaises with the Lake County Coalition for the Homeless
 - Staffs and coordinates homeless funding decisions with the Coalition
 - Conducts the Annual Homeless Census (Point in Time Count)
- Manages the ServicePoint Referral Network
 - Integrates with Lake County 211 (United Way of Lake County)

Investing Funding with Community Partners

Funding is managed under four goals:

- 1. Improve homeless crisis response system
- 2. Assist persons with special needs (including mental health)
- 3. Maximize affordable housing
- 4. Prioritize pathways for upward economic mobility

Federal fiscal years run October 1 – September 30 Data from HUD's System Performance Measures Report

- The daily census of people in emergency homeless shelters and domestic violence shelters is reflected in higher point in time number from 1/26/2022 (402 up from 372 in 2021).
- Length of time homeless is nearly triple what it was pre-pandemic (110 days in the year ending 9/30/2021 compared to 38 days.
- People experiencing homelessness are less likely to exit to a permanent destination (46% compared to 59%).



Rental Assistance and Eviction Prevention



- Local program, Federal Emergency Rental Assistance Program (FERA) has distributed \$23,167,734.81 of direct assistance to 3,092 households.
- With ~\$32M of assistance available, the program will wind down in 2022.
- Bilingual staff are available at eviction court (in person and virtual) to assist with applications.
- State of Illinois (IHDA) will have an upcoming round of rental assistance (<u>https://www.illinoishousinghelp.org/</u>) in April.

Attainable Housing



- Expansion of the multifamily rental portfolio by 287 units in 7 buildings
- Expanded homeownership support
 - Launched foreclosure prevention program in partnership with courts
 - Down payment assistance to 47 households
 - Completed 8 community land trust homes
- Innovative partnership with Lake County Housing Authority to preserve 18 affordable single family home rentals

Plans for the Coming Year



- Continue to support allocation, contracting and management of one-time Federal funding (i.e. HOME-ARP, ARPA SLFRF).
- Project management and reporting on an increased portfolio of grants.
- Wind down the Federal Emergency Rental Assistance (FERA) program.
- Facilitate plans to end chronic homelessness with the Lake County Coalition for the Homeless.
- Staff the Planning, Building and Development's Attainable Housing Task Force (PWPT authorized).
