The final award of the use of this contract is contingent upon approval by the Lake County Board at their meeting scheduled on May 10, 2022. A formal purchase order will be issued following this meeting.

Conference Technologies, Inc. will provide an upgraded and enhancement to the existing AV system through use of digital based components utilizing the latest technology in providing for best performance and reliability throughout.

Nineteen Center Courts and Two Court Tower Extension courtrooms. Four Traffic Court courtrooms replacing existing displays only.

The existing video system and assistive listening systems will remain. A new HDMi wall plate transmitter and receiver will be installed in each courtroom. Based on the information provided the current assistive listening system is a two channel Williams Sound. Additional receivers may be needed to provide the Interpreter use.

Twelve existing plasma displays will be replaced with new digital HD 65" displays. Six are wall mounted and six are pole mounted. C401, C402, C403, C404, C405, C303, C304, C305, C201, C202, C204, C205

The existing audio system will be upgraded to include microphones. One microphone for the Judge, Witness, and each Attorney table, Well microphone and/or Microphone input and sidebar microphone.

In eleven courtrooms quantity two gooseneck microphones will be provided for the Jury Box location.

For the Judge a side bar microphone is included. A new digital signal processor and amplifier are included to provide clear audio for Zoom and recording. Existing in room speakers will remain. All related cable will be included.

Based on the information provided the recording format will be a PC located for each room. CTI will provide a feed for the recording PC. Set up for the recording PC provided by others.

A new control system will be provided for the audio to accommodate the new components along with touch panel pages for operator control.

Each Courtroom will have its own wall rack where the components will be located (excluding Courtrooms 101 and 107 which will have a rack under the Judges bench). Included is Wiremold floortrack for the Courtrooms.

Please note that all electrical power, network, phone, and structural requirements are to be provided and installed by others along with a soft codec Zoom license loaded onto an existing PC. Any repair or replacement of the existing equipment either requested or necessary will be added to the cost of the project. All cables and connectors necessary for integration will be provided. Installation will occur according to an agreed upon schedule with on-site work performed during normal business hours. Project delays due to either or both incomplete infrastructure requirements and unavailable site access once scheduled and confirmed will be added to the cost of the project. A dedicated Project Manager will be assigned for coordination of all work and will schedule a training session with users at a mutually agreed upon time. Protective coverings will be utilized with all work around owner furnishings.


