# **Circuit Court Overview**



- 19<sup>th</sup> Judicial Circuit 1 of 25 judicial circuits in the state and is an independent branch of government whose authority vests in the IL Constitution and Illinois Supreme Court, Statutes, IL Supreme Court Rules and 19<sup>th</sup> Circuit Court Rules.
- <u>Mission</u> To serve the public by providing access to a fair and efficient system of justice that is committed to excellence, fostering public trust, understanding and confidence.
- <u>Chief Judge</u> responsible for administration of entire court organization, the assignment of judges, and is employer for all non-judicial staff. Serves as liaison to the Illinois Supreme Court and the Illinois Conference of Chief Circuit Judges.
- Presiding Judges of Court Divisions oversight of court activities within division.
- <u>Executive Director</u> oversight of day-to-day administration of operations, budget, human resources, technology and court programs, including probation and detention services.
   Also serves as liaison to the Lake County Board and county departments.

  - 24 fully state-funded (4 Court Reporter vacancies)
  - 237 FTE (21 vacancies)
    - 162 positions state reimburses salary
  - 12 PTE (2 vacancies)




#### 19th Circuit New Case Filings, Case Dispositions, and Clearance Rates Between 2010-2021

# **Previous 12 Months**



- Operated courtrooms and programs during pandemic with strong reliance on virtual practices. Resumed limited jury trials using social distancing.
- Court's ICMS Team collaborated with other justice partners in development of new ICMS.
- Initiated use of Electronic Court Reporting (ECR) in select courtrooms at Court Tower.
- Non-exempt court employees (164 employees) certified AFSCME to represent them in collective bargaining. Negotiations began on initial agreement.
- Elected new Chief Judge and created new alignment of judicial divisions and judge assignments.
- Applied and received Juvenile Redeploy Planning and Implementation Grants to expand community-based services to youth.
- Received CARES Act funds to expand Eviction Mediation Program.
- Participated in MacArthur Grant SJC program. Implemented new PSA risk assessment tool for Bond Court and expanded upon text notification to offenders.
- Shared information for research into the elimination of juvenile court fees.
- Coordinated with FCS on relocation and return of Adult Probation staff for roof repair at facility.



# **Next 12 Months**



- Continue to reconstitute all courts and services in post-pandemic environment <a>
  </a> incorporating continued use of virtual hearings, meetings and services where appropriate.
- Complete development and implementation of ICMS with justice partners.
- With help from AOIC, expand ECR to juvenile and bond courtrooms.
- Implement Court Technology Modernization projects related to the \$1M grant from Illinois Supreme Court.
- Continue and/or complete negotiations on initial AFSCME agreement with nonexempt court employees.
- With FCS, implement alternate Capital Improvement Plan at Juvenile Facility.
- Add revenue by housing minors from other counties.
- Implement new Bail Reform law and no cash bond.
