Background



- **The Greenest Region Compact was adopted by the County Board in 2019**
 - **141 Communities**
 - **6 Million Residents**
 - **Largest regional sustainability collaborative in the country**
- **“The Framework is designed to help communities assess their current initiatives, select suitable goals and actions, and tailor objectives and strategies to advance their own sustainability agendas.”-GRC Website**
- **The Framework was updated for 2022 by Sustainability Program Manager**

- There are 49 goals within the Compact designated into 10 sustainability categories
- The Greenest Region Compact Framework is a tool designed to assess current initiatives and advance sustainability agendas




- **The Framework exercise has given a good overview of the County's initiatives for Sustainability Program Manager**

Recommendations



- **Ideally achieve a 95% adoption for objectives and strategies in the Compact**
- **Provide a complete updated version of the Framework for public viewing on the Lake County website**
- **Pursue Metropolitan Mayor's Caucus environmental grants to meet objectives in the Compact**
- **Be active members of Metropolitan Mayor's Caucus committees, such as their Environment Committee**
