#### **Section II - Program Narrative**

a) What is your proposed project or program? Please describe the project or program for which you are requesting grant funds.

The Nineteenth Judicial Circuit proposes three main uses of the grant funds for the 2022-23 grant cycle: 1) Funds to continue the Early Resolution Program; 2) Funds to continue the chat feature on the circuit court's website; 3) Funds to continue to provide incentives for eviction mediators

1) The Early Resolution Program has been held remotely for the past two years through the use of Zoom, email, and DocuSign. The Self-Represented Litigant Coordinator altered the in-person procedures with the assistance of the contracted Prairie State Legal Services attorney to accommodate remote consultations and review of paperwork. The program successfully proved up 61 cases (122 SRLs) over 9 program dates between July 2021 and May 2022 with an average of 7 cases per program. Additional cases are expected to prove up through the program in June. The Nineteenth Judicial Circuit values the Early Resolution Program as an integral component of SRL Courtroom goals.

The Program initiates contact with SRLs by mailing letters and brochures (created via Canva) to qualifying cases. Parties interested in finalizing their divorce quickly and efficiently are instructed to contact the Coordinator who provides the necessary documents along with procedural information. A Zoom meeting is then scheduled between the litigants, the Coordinator, and an attorney from Prairie State Legal Services. The attorney assists the parties to finalize their documents and ensure that there are no outstanding legal issues. The Coordinator manages the documents to completion and signature. These cases are then scheduled for a prove-up via Zoom on a monthly basis. From start to finish, the process is entirely remote, but requests for inperson assistance can be accommodated. The grant funds received would support the continuation of this program by maintaining the indispensable partnership with Prairie State Legal Services and by funding the annual DocuSign subscription that facilitates electronic signatures. It would also allow for the creation of new brochures and signage with a Canva account.

2) The installation of a chat platform on the circuit court website became an immediate necessity due to the pandemic as a way to share resources and information with litigants remotely, but it quickly became apparent that this service will remain a helpful tool for litigants in a post-pandemic world. Through this feature, it was confirmed that litigants with questions about court visit the circuit court website to seek answers and that having a way for them to communicate with a representative is a successful method for providing information.

Four representatives: the SRL Coordinator, Justice Corps Fellow, and two Law Library staff monitor the chat and respond to inquiries. Court users are instructed to leave a

message with their question, and a representative will email them the answer. When staff is available, the feature allowing for live chat conversations is enabled. From July 2021 to present, 2,134 messages have been answered, and from March through May of 2022, 405 live chat conversations occurred. Typical inquiries relate to remote court access, where to obtain forms and how to submit paperwork. The Nineteenth Circuit is committed to the continuation of this service.

3) The Nineteenth Judicial Circuit Eviction Mediation Program has been in place for several years and has a consistently high resolution/success rate. The mediators are volunteer attorneys that would previously come in person on days when SRL cases were scheduled to conduct mediation between the parties in a conference room. One mediator typically completed two or three mediations per court session.

With the rise in eviction cases that followed the end of the pandemic-era moratoria, two or three mediations per court session is not nearly enough. In order to manage the increased caseload, on the first court date the case is continued for 30 days. This gives the self-represented parties time to contact a mediator and schedule a mediation prior to their next court date which allows the mediators to conduct far more mediations. Consequently, the volunteer attorney mediator's workload has been vastly increased. With this grant in addition to seeking other funding sources, we hope to be able to offer a small monetary compensation per mediation session (\$50) as an incentive for mediators to continue to volunteer for this program despite the increased workload.

- b) What are your goals for the project or program? Please list specific objectives and any steps that will be taken to achieve them.
  - 1) The goal for the Early Resolution Program is to continue remote access and maintain the positive feedback from participants gathered via surveys. The original program goals will be preserved:
    - Establish a simplified process
    - Reduce the number of court appearances
    - Reduce the number of post-case motions and hearings
    - Increase education for court users
    - Increase public trust and confidence
    - Increase user satisfaction
    - Provide meaningful access to the judicial system.
  - 2) The goal for the LiveChat feature on the website is to maintain the staffing level of four trained representatives. With this amount of representatives, the live chatting feature can be enabled for certain predetermined time periods throughout the week with the leave a message function enabled at all other times.

- 3) The goal for the Eviction Mediation Program is to assist the increased number of selfrepresented litigants to reach a resolution outside of the courtroom by providing incentives for mediators to volunteer.
- c) Who will partner with your Coordinator to achieve these goals? Please describe any proposed partnerships that will enhance the work of the Coordinator. These goals could not be met without the cooperation of court partners. Namely, Prairie State Legal Services, JusticeCorps, the Law Library, the Lake County Bar Association, the Circuit Clerk's office, and the Arbitration Center.

Previous grant funding allowed for the partnership with Prairie State Legal Services to grow, and this relationship will be sustained with any new grant funds. The Nineteenth Circuit is fortunate to have a JusticeCorps Fellow stationed in the Law Library to provide SRLs with assistance both remotely and in person in addition to monitoring chat inquiries. The Law Library staff will continue to assist SRLs with Zoom and provide paperwork. The Lake County Bar Association is supportive of the SRL Program and exchanges information and resources with the Coordinator. The office of the Circuit Clerk has supported the Early Resolution Program by scheduling cases for the designated prove-up date, accommodating SRLs with scheduling conflicts, and quickly processing e-filed documents of program participants. The Arbitration Center will continue to coordinate with volunteer mediators and maintain their schedules.

d) How will the Coordinator evaluate the effectiveness of their work? Please include a plan to evaluate the effectiveness of the Coordinator's initiatives. Evaluations should consider the impact on both litigants and court staff.

Evaluations are essential as the SRL program continues to navigate remote services and pilot new programs. Online evaluations tailored to SRLs will be sent via email following each Early Resolution Program date. The Coordinator will continue to evaluate the Early Resolution Program by tracking data including the number of cases that are proved-up through the Early Resolution Program, the number of days between filing and resolution of those cases, and the total number of court appearances for each case. The JusticeCorps fellow will continue to track their total number of patrons assisted and the type of assistance provided. The LiveChat program is equipped with data tracking tools that provide information about number of messages received in any given period and at what time of day messages are most frequent. The live setting allows patrons to rate the chat experience as well. The Arbitration Center will track the frequency and success rate of the eviction mediation sessions.

  - Adding a dedicated Coordinator was supported by the Lake County Board in 2019 and has been incorporated as a regular position within the Circuit Court's annual budget going forward. The Coordinator is committed to maintaining current projects in addition to improving upon them and establishing new ones. Previous grant funds established a dedicated SRL space in the Law Library and purchased equipment for the Coordinator and the JusticeCorps Fellow. These additions continue to provide stability for the program moving forward, and we plan to continue to improve upon them as our needs change. The Coordinator will be able to preserve the current level of service via LiveChat with the assistance of the law library staff, a JusticeCorps fellow, a summer intern, and a part-time volunteer.

These past two years as Self Represented Coordinator for the Nineteenth Judicial Circuit have been an extremely rewarding experience. I had the honor not only of being the first person solely dedicated to that title in this circuit, but I was also able to guide the program through the pandemic by converting previous programming to a remote platform. I also had the chance to implement and oversee additional remote services including the chat feature on our website. Now that we are in a "post-pandemic" era, I am looking forward to combining best practices of remote assistance with our ability to offer in-person services again.

Beginning this role in a pandemic was challenging but also allowed me to be on the forefront of best remote practices as it pertains to SRLs. Lake County has been extremely supportive of these endeavors which has allowed our program to excel. Consequently, I was asked to speak at conferences and webinars about the Nineteenth Circuit's remote procedures. I served as a faculty member for the Illinois Judicial College and spoke at the Judicial Educational Conferences regarding remote SRL proceedings.

Though our program excels, I acknowledge that there is always room for growth and development. In order to continue to gather ideas to improve services, I attend state and nationwide webinars pertaining to SRLs and previously was a member of the National Center for State Courts Implementation Lab to network, share ideas, and troubleshoot any issues. I also attend the monthly Illinois coordinator network meetings and trainings which have proven to be an invaluable resource. In addition to national and statewide networks, I am committed to maintaining the relationships I have formed with local community organizations as well as partners within the court system so that our program can continue to grow. We will continue to work with JusticeCorps and are grateful for our fellows without whom we could not reach as many self-represented litigants in need. I am constantly seeking other options for growing our program and was recently able to hire a summer intern as well as a part-time volunteer in pursuit of this goal.

Through this journey, my passion for access to justice has only grown, and I am eager to use that passion to continue to improve upon services for self-represented litigants in the Nineteenth Judicial Circuit.

This letter is to support the 19<sup>th</sup> Judicial Circuit's application for renewed funding to the Eviction Mediation Program under the Illinois Supreme Court commission on Access to Justice and the Administrative Office of the Illinois Courts' Self-Represented Litigant (SRL) grant program.

The 19<sup>th</sup> Judicial Circuit is committed to increasing Access to Justice to Self-Represented Litigants. In July of 2012 the ADR Center administered a mediation program for SRLs only in both Small Claims and Eviction Courts. The programs included volunteer mediators and was highly successful. Unfortunately, we unable to expand on the programs. The funding from last year allowed the 19<sup>th</sup> Judicial Circuit to expand the program to include all SRLs, including those who are in a case with an attorney representing the plaintiff in eviction cases.

The revamped eviction mediation program has been very successful. One hundred seventy-six eviction cases were mediated in Lake County from October 2021 – March 2022, and 70% of those cases resulted in a full agreement. While the tenant may not always want to or be able to stay in the home where they currently reside, they now can ask for things that would be helpful to them, such as longer time prior to move out or a reduced or eradicated back rent bill. This new eviction program would not have been possible without the funding. Any further funding that becomes available that could help support an employee that was dedicated to the eviction program would also be very beneficial.
