ADMINISTRATIVE ACCOMPLISHMENTS - Wauconda

- As the Chairman of the Wauconda Area Substance Abuse & Prevention Coalition, our research
 and grant request has been awarded the Community Anti-Drug Coalition of America (CADCA)
 grant. This grant provides \$125,000.00 per year for up to 10 years.
