## Connecting the Dots— Naloxone Distribution:

During 2023, multiple programs within the Lake County Health Department worked together to prevent overdose by distributing naloxone and fentanyl testing strips throughout the community. This was done through mail orders, pickup, health center distribution, and events. This effort has led to great success with over 4,000 naloxone orders being submitted.

## Connecting the Dots— Uniting for Ukraine:

The Health Department's Tuberculosis (TB) Program received the Uniting or Ukraine grant in order to conduct outreach to Ukrainian refugees in Lake County. In 2023, our TB clinic had 225 Ukrainian Humanitarian Parolee visits, a 257% increase from 2022. The Uniting for Ukrain grant illustrates how the program is supporting our most at risk populations by providing them services, increasing TB awareness and connecting them with resources in the area

## Connecting the Dots— Animal Care and Control:

ing October 2023, the Health Department's Animal Care and rol (AC&C) program received a call about a home housing cats. AC&C arrived and realized that the situation was much more severe than initially reported. During the first visit, 84 cats collaborative deicing were collected by four AC&C staff over the span of 5.5 hours. AC&C immediately reached out to its shelter partner, Orphans of the Storm, to assist with the adoption of the cats. Thus far, 110 cats were taken out of one home with 75 transferred to ohans of the Storm for adoption.
