1993 – Moved to a day administrative position to assist the then Chief with overall department operations and coordination. Began a process of building and staffing 3 additional Rural Fire Protection District stations to meet geographical positioning and assist response times as possible. Last station opened in 2001.

1997 – Promoted to Deputy Chief through Fire and Police Commission testing process.

July 2011 – Appointed Interim Fire Chief/Emergency Management Director with the retirement of the Fire Chief.

August 2011 – Appointed by the Mayor as the Fire Chief/Emergency Management Director. Currently handle a department with 55 sworn members, 4 civilian personnel, 4 stations covering 25 sq. miles and approximately 37,000 residents. The department is a full service department providing all Fire and EMS services along with specialized rescue teams and a highly qualified Fire Prevention Bureau. Our budget is currently in the \$11 million range. In addition to the Fire Chief position I also hold the Emergency Management Directors position for the Village of Lake Zurich. The Emergency Management position encompasses ensuring that the Village has an adequate plan for emergency operations and that all Village departments are prepared to successfully contribute to the mitigation of and recovery from any natural or manmade hazard/situation that may affect the Village.
