LEGISLATIVE

CMAP County Board Chairs Meeting

Last month, the Cook and Collar County Board Chairs as well as the Deputy Mayor of Chicago convened for our quarterly meeting. Topics of discussion included updates on the recently enacted federal transportation bill named the FAST Act, the Local Technical Assistance (LTA) program and the impacts of the state budget impasse on CMAP's finances.

CMAP is beginning to develop the framework for the successor to the GOTO2040 Plan. The Chairs received a presentation on concepts up for consideration in the plan and provided feedback. The group also discussed the ongoing issue of underfunded infrastructure in the region.

Lake County will again coordinate the Cook and Collar County Legislative Agenda. We are in the process of compiling requests for legislation from our peer counties and will finalize the agenda in the next month. The Chairs are also continuing to look for additional ways to coordinate at the federal level on transportation-related legislation.

Finally, we discussed the successes of the "Growing Our Regional Economy" forums. The next event will be held in Kane County next month.

NON-PROFIT

United Way of Lake County "Collective Impact" Initiative Kick-Off and Planning Session

I recently took part in a workshop to kick-off the United Way of Lake County's "Collective Impact" initiative. A diverse group of private-sector, non-profit and government leaders came together to discuss how we can achieve better alignment of educational curriculum and private sector needs as well as identify barriers to success that Lake County residents face such as housing, healthcare, food security and transportation. The United Way will be convening committees to lead the effort and develop a broad cross-section of advocates.

TRANSPORTATION

Route 53/120 Tollway EIS Vote

The Tollway Board unanimously voted to commission an Environmental Impact Statement (EIS) for the Route 53/120 project. I provided public comment during the meeting to stress the importance of the enhanced environmental standards and community protections detailed in the Blue Ribbon Advisory Council's (BRAC) 2012 recommendations. As the EIS progresses, it is critical that Lake County and our residents engage in the process to ensure the BRAC is utilized as the intellectual framework for the Route 53/120.

FAST Act Press Conference with Congressman Dold

Just before the holidays, I joined with Congressman Dold at a press conference to highlight the recently enacted federal transportation bill named the "FAST Act". The bill is a five-year, fully funded transportation authorization. It increases funding for locally owned infrastructure like county highways by 55%, creates a new \$800 million competitive freight rail program and approves new, streamlined policies for project delivery – among other things.

New Law About Caring for Pets

A new law under the Humane Care for Animals Act went into effect on January 1st making it a Class A misdemeanor offense for owners who expose their companion animals to extreme heat or cold conditions for prolonged periods of time creating a life-threatening situation.

Pet owners should take extra precautions during this extreme cold weather:

- · Limit the amount of time pets are outside when temperatures are below freezing.
- Provide coats for short haired pets, watch for and remove snow/ice buildup on pets with longer hair.
- Frostbite happens quickly! Watch for signs of hypothermia or distress: redness of the skin particularly around the ears, nose, and paw pads.
- Keep pets away from harmful chemicals such as antifreeze or deicers which can easily become stuck between the paw pads.
- Use caution with space heaters as pets can brush up against them or knock them over, potentially starting a fire or causing injury to the pet.
- Always walk dogs on leash, staying away from ice. Make sure the pet's collar is secure with an up-to-date rabies registration tag.
- Provide proper shelter if your pet cannot be brought inside, including:
- o A solid, draft-proof shelter that protects against wind and is water resistant;
- o Thick, dry bedding that should be changed regularly to provide a warm, dry environment to sustain body temperature; and
- o Access to fresh food and clean, drinkable (non-frozen) water heated water bowls are recommended.

Rule of thumb: If it's too cold for you, it's too cold for your pet!

January is National Radon Action Month

January has been designated National Radon Action Month by the Environmental Protection Agency. In connection with this observance, the Lake County Health Department/Community Health Center is encouraging residents to check the radon levels of their homes or apartments in January or during the winter months. The best time to check for radon is during cold weather when windows and doors remain closed. Short-term test kits are available through the Health Department for \$10.00. The cost includes return postage, laboratory analysis and interpretation by Health Department staff. Test kits are also available from area hardware and building supply stores. Health Department Trains School Personnel to Use Naloxone As part of an ongoing effort to reduce the high rate of heroin and other opioid overdoses in Lake County, the Health Department will be training 30 teachers and nurses from the Waukegan school district at the Lincoln Center in Waukegan this month to use naloxone, a medication used to reverse drug overdoses. The Health Department, which is a member of the Lake County Opioid Initiative, has already trained numerous law enforcement officers to use the product, which they use when responding to calls of suspected opioid overdoses. As a result, 46 lives have been saved since Christmas day of 2014.

LAKE COUNTY PARTNERS COUNTY BOARD UPDATE JANUARY 2016

As Lake County Partners moves into the New Year, the organization is seeking to build on recent economic development successes and expand its services in the areas of workforce development, coordination and public outreach to support Lake County's many businesses and communities.

- Through its Business Outreach Program, Lake County Partners has met with senior leadership at over 100 local businesses to discuss and address specific needs. As a result, staff has made over 50 connections with local agencies and organizations to efficiently establish talent pipelines, internship opportunities, and training programs. This program will accelerate in 2016, and businesses may request a visit at www.lakecountypartners.com
- Last year, Lake County Partners formed the Municipal Economic Development Advisory Group to provide a quarterly forum to assist municipal staff. Meetings coincided with the dissemination of over 200 customized reports with data that municipalities can use to attract business. Lake County Partners also invested in analytical tools that have improved the organization's ability to connect with/refer potential leads and assess the

economic impact of proposed projects. The meeting series and method of data reporting will continue in 2016.

- In 2015, a steering committee was established to oversee the launch of the Leadership Lake County initiative to attract and retain young professionals, aged 22-39, in Lake County. The group conducted public outreach through focus group discussions with young professionals and a survey of human resource professionals in Lake County. The committee is currently aggregating the feedback and using it to identify local challenges and strengths; in early 2016, the findings will be shared with local stakeholders and used to shape long-term objectives for the initiatives.
- The promotion of Lake County's assets continues to remain a key priority. Lake County Partners manages a website, quarterly e-newsletter and 5 social media platforms and uses these channels to communicate information of importance to businesses. The organization will also continue to communicate through periodic reports, listserv announcements, presentations and its annual meeting, to be held in 2016.
