#### WORKFORCE DEVELOPMENT

## 7.1 <u>16-0290</u>

Joint resolution approving an emergency appropriation to accept an additional \$253,739 in workforce grant funds from the Illinois Department of Commerce and Economic Opportunity (DCEO) for fiscal year (FY) 2016.

Jennifer Serino, Workforce Development, reported on three grants approved by the Department of Commerce and Economic Opportunity (DCEO) totaling \$253,739. The disability Emloyment Initiative grant, the Workforce Investment Act Rapid Response grant, and the Trade Adjustment Assistance grant will be used to improve access for skilled workers with disabilities, purchase accessibility furniture, and purchase software/equipment to better serve disabled job seekers. The grants will also support the cost of personnel associated with serving the dislocated workers through trade events and the administrative cost of payment processing.

## 7.2 <u>16-0287</u>

Joint resolution authorizing contracts with various firms for the Lake County Workforce Development's Youth Program Services in the amount not to exceed \$822,545.59.

Gary Gibson, Workforce Development, reported on the six proposed contracts for the Workforce Development's Youth Program. It was noted that the Purchasing Department assisted in the bid process to help determine which responders would best fit the needs of the program.

Jennifer Serino, Workforce Development, added that the Youth Program is expected to have a similar outcome as last year.

#### **COMMUNITY DEVELOPMENT**

Chair Carlson requested an update on PADS. Jodi Gingiss, Community Development, noted that the PADS day center, located in Waukegan, recently had their buisness license revoked. The Center is allowed to operate for 28 days, during which time a city hearing will take place on whether or not to permanently revoke the business license. The City of Waukegan feels that the building is not zoned properly for the activity taking

place at the Center. The city has experienced numerous complaints from residents and other businesses and it is Waukegan's preference to relocate the Center. A discussion needs to occur with the City of Waukegan and PADS Lake County to decide which of their zoning categories would fit the needs of a homeless service center. The City of Waukegan is currently working on trying to identify an appropriate location for the facility.

## 7.3 16-0050

Joint resolution approving the 2016 Housing & Community Development Annual Action Plan, authorizing all necessary correspondence for the distribution and implementation of the plan with the U.S. Department of Housing and Urban Development.

Jodi Gingiss, Community Development, provided detail regarding the Community Development 2016 Action Plan allocating nearly \$3,000,000 in community development and housing funds from the U.S. Department of Housing and Urban Development. The focus will be on down payment assistance for first time home buyers in Lake County and small projects such as Lake County Haven's search for a location in Libertyville or Deerfield to house a second shelter for women and or children recovering from substance abuse.

Joint resolution authorizing grant awards from the 2016 Lake County Affordable Housing Program (LCAHP).

Jodi Gingiss, Community Development, expressed how thankful the department is for Lake County's commitment to the Affordable Housing Program and the funding for projects such as rental assistance, credit repair and foreclosure prevention counseling, a multi-use property in Highland Park for rehabilititation services, a group home in Libertyville, and a new project with Youth Conservation Corps for youth training purposes.

Jodi Gingiss, Community Development, informed the committee the CDBG funds become available May 1, and the proposed MOUs allow the sub-recipients to begin their projects

while waiting for HUD to provide the grant agreements in June or July.
