Inter-Governmental Agreement 864-13 Modification 1 is hereby modified as follows in accordance with Section 4 of the original agreement:

**3. PERIOD OF PERFORMANCE:**

This agreement is modified to extend the ending dates from **June 30, 2016 to June 30, 2023**. Please be advised that this modification extends the period of performance, but does not modify rates. Price redetermination shall, if allowable, be adjusted upward or downward in accordance with the base agreement at Part 9.

**7. PAYMENT RATE:**

All estimated values, for applicable periods, remain as is, in accordance with base agreement.

**24. ELECTRONIC TECHNOLOGY, CELL PHONES:**

The following is compliance language for Cell Phones.

Contractors must develop procedures to allow for the routine use of cell phones. Any restrictions of use, other than those outlined below, must be approved by the Residential Reentry Management (RRM). The cell phone policy procedures must contain at a minimum:

- Cell phones will not be used as the sole means of accountability.
- Contractor will develop a cell phone agreement to be signed by all residents which outlines cell phone use.
  - No resident-to-resident contact will be allowed to include calls, text messages, e-mails, photos, or other contact.

25. **AFFORDABLE CARE ACT (ACA) :**

The Patient Protection and Affordable Care Act (P.L. 111-148) requires U.S. residents to be enrolled in an approved health insurance plan beginning January 1, 2014. Failure to enroll will result in a monetary fine. While incarcerated persons are excluded from the requirement, they will be required to enroll upon release. Therefore, to assist residents in meeting the requirements of this law, the Residential Reentry Center (RRC) will ensure internet and phone access is made available to all residents in order to facilitate the application process. Information regarding the application process is available on the website [www.healthcare.gov](http://www.healthcare.gov). Internet and phone access should also be made available for residents to access State Medicaid or Marketplace Navigators/Certified Application Counselors that provide free assistance. In addition, the Bureau may, at its discretion, provide materials for distribution to federal residents of the RRC.

The RRC is required to provide Affordable Care Act application information to each resident during the intake process. Prior to release, each resident will be surveyed to determine if they applied for a health insurance plan. The resident's self-reported information regarding their application for health insurance will be documented in a tracking log that indicates one of the following:

- Resident applied for coverage
- Resident's application is pending
- Resident has not applied to date
- Resident declined to register

Residents' self-reported information will be made available to the RRM upon request.

**All other terms and conditions of this Agreement remain unchanged.**
