Joint resolution authorizing an emergency appropriation in the amount of \$519,410 and accepting the 2015 Department of Housing and Urban Development's (HUD) Continuum of Care Homeless

Assistance grant awards.

- Lake County works in partnership with the Lake County Coalition for the Homeless to submit an annual application to HUD based on the funding recommendations of the Continuum of Care.
- Last week, Lake County received notice that it has been awarded \$2,105,513 through the Continuum of Care Homeless Assistance Grants, a decrease of \$201,743 relative to prior years. Also, local requests for an additional \$343,367 of available bonus funding were denied by HUD.
- In addition to \$165,561 for providing HMIS and CoC program coordination services to the CoC, community development will administer \$353,849 of the award (5 projects) on behalf of other agencies, the Health Department will administer \$445,164 (1 project), and the remaining amount of \$1,140,939 (7 projects) will be administered directly by authorized agencies.
- This resolution authorizes the appropriation of the homeless assistance grant awards, execution of the necessary subrecipient agreements and initiation by Lake County of the environmental review records required for these awards.

Discussion of 2015-19 Plan-To-Date Performance

- Lake County's 2015-19 Housing & Community Development Consolidated Plan (ConPlan) established significant housing, neighborhood revitalization and economic development goals. As activities are funded, there is an obligation to align funding commitments with the Plan's goals.
- At the start of planning for each new program year, staff reports on how funding trends support or detract from achieving the Plan's five-year goals. After two years (2015-16) of funding commitments, two specific goals [#5: Improving infrastructure in low/moderate income areas and #6: Revitalization low/moderate income business districts] have reached and exceeded the five-year target identified in the ConPlan. Conversely, based on the first two years' funding rate, other goals are not projected to meet the five-year targets as required by HUD.
- Consequently, this discussion will involve strategies for adjusting funding rates to appropriately meet all of the ten identified goals under the ConPlan.

He then spoke of several recent cases where he had assisted disabled individuals to keep or attain housing that could meet their needs. He voiced the opinion that many individuals could be helped with an increase in affordable units for persons with disabilities.

*Ms.* Jackie Lynn, Executive Director of ElderCARE, thanked the HCDC for the continued funding for her agency and then spoke of the increasing need for supportive services for the elderly, as the number of senior citizens continues to increase rapidly. She informed the HCDC of the services provided by the agency's volunteers.

*Ms.* Sonolito Bronson, of the City of Zion, thanked the HCDC for the recent grant awards. She agreed with Ms. Lunn that there were an increasing number of senior citizens in Lake County and stated that economic development was important, as attractive business areas would entice them to shop locally. She strongly encouraged that funding for business revitalization continues in the coming funding rounds.
