#### To Whom It May Concern:

I am providing this cover letter and accompanying resume to express my desire to be selected as the Emergency Management Coordinator – Lake County, Illinois. It is my belief that my qualifications exceed those detailed in the announcement. Below is a brief summary of my many years of experience in the emergency management and continuity industries.

Although much of what I am providing in this portion of the cover letter centers on emergency management, law enforcement management and community preparedness exercises, it has been included to demonstrate my extensive background in working and coordinating with managers at several different levels of government and the private sector. On several occasions I have been complimented on my ability to create diverse partnerships with key appointed officials and stakeholders from different industries and backgrounds in order to ensure that our mutual assigned tasks are properly completed.

In my current position as the Emergency Management Coordinator for the Chicago Department of Aviation, I coordinate with departmental staff and outside agencies to develop and update airport emergency management plans in preparation for and response to incidents. This includes the National Incident Management System (NIMS), the Incident Command System (ICS); Strategic National Stockpile (SNS) Continuity of Operations (COOP), Emergency Operations Center (EOC) activity, Pandemic Influenza program participation with the Center for Disease Control (CDC) and Evacuation/ Shelter-In-Place Planning. I have a thorough understanding of local government operations and have spent years building teams and strong working relationships with city / county /state and public sector personnel. In addition to certifications in Crime Prevention, Emergency Management, Exercise Design / Development / Evaluation, I am also certified as a Continuity Practitioner ensuring that my Department is prepared to continue with its' mission essential functions should some disaster strike - temporarily incapacitating the senior appointed leaders or critical infrastructure / key resources of the department.

I co-authored the department's Emergency Operations, Active Shooter and Continuity of Operations Plans and have spent countless hours reviewing and updating these plans with key personnel, airport tenant agencies and our Risk Management consultants to ensure that we are prepared to address the mitigation, preparedness, response and recovery concerns associated with emergency planning. Since my arrival at the Aviation Department, we have addressed such real-world issues as: 2006 Terrorist Plot Against U.S. Aviation Industry; 2009 Swine Flu Epidemic Scare; 2010 Severe Wind Storms; 2010 Stanley Cup Playoffs; 2010 Haitian Relief Effort; 2011 Winter Blizzard and the 2012 NATO Summit.

As the Lead Planner for the Department of Aviation's Exercise Design and Development Team, my responsibilities include the planning, design, development, evaluation and management of all drills and exercises conducted by the Department. These drills and exercises often focus on airport critical infrastructure and key resources that are vital to the nation's air transport industry. In order to further develop my exercise design/management skills, I have earned the designation of Master Exercise Practitioner (MEP) from FEMA (Federal Emergency Management Agency). I hold numerous other certifications conferred by the Illinois Emergency Management Agency (IEMA), the Federal Emergency Management Agency (FEMA) and the private sector.

In recognition of my strong team building and communications skills, I was awarded the Chicago Department of Aviation, Safety and Security Divisions' John J. Townsend Award of Excellence; the Department of Aviation 2006 Distinguished Service Award and am a 2015 recipient of the

International Police and Public Safety 9/11 Medal of Commendation. Each of these awards point to a successful track record to attain successful results.

Prior to my assignment with the Department of Aviation, I was a non-sworn member of the Chicago Police Department where I served as the District Manager for the 12<sup>th</sup> District with responsibility for the management of all administrative functions (reports, records retention and disposal, crime and arrest reporting, timekeeping, and officer activity). Working together with the District's Community Policing Staff, I was required to work closely with several layers of government (city, county and state) as well as the private sector to further the Chicago Alternative Policing Strategy (CAPS) embraced by the City of Chicago Leadership. In this capacity, I provided support and coordination to the department in it's' dealings with private sector businesses and educational institutions.

A promotion to Projects Administrator for CPD's Patrol Division resulted in responsibilities for managing the needs of 25 police districts and 28 division units directly servicing over 10,000 of the police department's 13,000 police officers. Responsibilities included: Project Management, Special Event Planning, contingency planning, preparing division level directives; preparing the division budget; determining manpower needs; establishing internal controls to ensure compliance with directives.

Reporting directly to the Chief of Patrol, I assumed the role of Staff Director. Additional duties placed me in a position to monitor the Performance Measures system to track issues such as: Safety (injuries, accidents and training); Crime (incidents and arrests); Citations issued (non-criminal offenses); employee overtime; and employee sick time.

My oversight of these areas placed me in a unique position as a member of the Department's Strategy Development Team where long-range strategic plans were designed and developed to address the deployment of police personnel to such large city-wide events as: 1996, 1997 and 1998 NBA Championship Series; 1996 Democratic Convention; 2000 Y2K "Bug" scare (while at the District level); and the 2004 Anti-War Demonstrations and the 2005 MLB World Series (while at the Division level).

I was recognized for my achievements in these positions by being awarded two Chicago Police Department Superintendent's Award of Merit and three Honorable Mentions for Administrative Excellence.


