Re: Lake County Coalition for the Homeless presentation

Date: September 29, 2016

The Lake County Coalition for the Homeless is a long-standing membership organization for our local homeless assistance non-profit organizations and County agencies. They use the acronym LCCH and function as the "Continuum of Care" for McKinney-Vento funding from the U.S. Department of Housing & Urban Development (HUD). Their current funding level is just over \$2 million and benefits the agencies listed on the next page.

The Continuum of Care originated in the early 2000s within the Lake County governance structure. It was staffed by Community Development. Until 2008, the Lake County Board approved Continuum of Care funding applications to HUD annually. In 2012, the federal government released guidance encouraging the Continua of Care to become separate from local government and as a result, the local membership organization (LCCH) took over its own funding approval processes.

Throughout this time, Lake County Community Development served the roles of both "Collaborative Applicant" managing the electronic HUD application process and Homeless Management Information System (HMIS) lead. In 2016, Lake County entered into a Memorandum of Understanding (MOU) with LCCH to formalize its role as Collaborative Applicant and technical advisor.

The presentation at HCS will be an overview of LCCH's purpose and activities by Dr. James Menzer, Homeless Education Coordinator for the Lake County and McHenry Counties Regional Office of Education. For LCCH, Dr. Menzer serves as the Chair of the Membership & Advocacy Committee.
