Military Career:

Captain Dennis E. Manning was commissioned an Ensign in the US Naval Reserve 1925 I Program during his freshman year in dental school. Immediately following graduation from dental school, he reported for active duty to the US Navy Dental Clinic, Long Beach, California where he served from July 1966 through June 1967. He was assigned to the Headquarters Support Activity, Taipei, Taiwan, Republic of China from July 1967 through June 1969. This was followed by an additional assignment at the Naval Administrative Command, Great Lakes, Illinois from July 1969 through June 1970.

On separation from active duty, Captain Manning continued his Naval Reserve career affiliating at the Naval Air Station, Glenview, Illinois. His subsequent Naval Reserve Assignments include the following: Squadron Dental Officer, Naval Reserve Division V-1 and V-2, NAS Glenview; Dental Officer, 4th Marine Aircraft Wing, Marine Air Reserve Training Command, 14th Dental Company, H&HS 48, NAS Glenview; Squadron Dental Officer, Naval Air Station 713, NAS Glenview; Staff Dental Officer, 4th Marine Aircraft Wing, Headquarters, Marine Air Reserve Training Detachment, 14th Dental Company, H & HS 48, NAS Glenview; Staff Dental Officer, Commander, Naval Air Reserve, NAS Glenview; Executive Officer and Commanding Officer, Naval Regional Dental Center Great Lakes, Detachment A, Great Lakes, Illinois; Training Officer and Administrative Officer, Voluntary Training Unit Dental 1314, Great Lakes, Illinois; Battalion Staff Officer, Reserve Naval Mobile Construction Battalion 25, Great Lakes, Illinois; Dental Officer, Naval Station Midway 0972, NAS Glenview; Executive Officer and Commanding Officer, Naval Dental Clinic, Great Lakes 213, Forest Park, Illinois; Commanding Officer,

Captain Manning is entitled to wear the following military decorations and awards; the Meritorious Service Medal (two awards); the Meritorious Unit Citation; the Fleet Marine Force Ribbon, the National Defense Service Medal (two awards); the Armed Forces Reserve Medal with Two Hourglass Devices; and the Expert Pistol and Rifle Marksmanship Ribbons. Captain Manning received the Rear Admiral William J. H. Vaughn Award as the "Outstanding Naval Reserve Dental Officer" in 1982 and was the Commanding Officer of the Unit receiving the Rear Admiral William J. H. Vaughn Award as the "Outstanding Naval Reserve Unit" in 1984.
