The agency has 620 public housing units, 2,603 housing choice vouchers, 586 new construction units, a family self-sufficiency program, a family unification program, a comprehensive housing counseling program, and Aim North Development Corporation (501c3). LCHA's external environment has over 700,000 citizens, 300 independent taxing entities including, 18 townships and 52 municipalities.
