The various respondents confirmed through their proposals that they will propose to provide either assessments or treatment as indicated using best-practice or evidenced-based modalities of treatment for either the juvenile or adult population they will serve.

## **EVALUATION OF PROPOSALS:**

Lake County evaluated the Proposers response and the extent to which it meets the requirements delineated in this RFP. All proposals submitted in response to this RFP were scored based on the ability to meet or exceed the following evaluation factors:

- Cost Proposal
- Experience with government employers
- Experience in providing Psychological Services
- Project Plan

## **DEPARTMENT RECOMMENDATION:**

The Psych Services Division and the 19<sup>th</sup> Circuit Court recommends awards to One Hope United, Lake County Health Department, Nicasa, Behavioral Services, A Safe Place, Omni Youth Services, Community Youth Network, Adelante, Blain and Associates, Creative Counseling and Evaluation, and Vista Health based on the criteria set forth in the Request for Proposal and reference checks. The Evaluation Committee comprised of representatives from Lake County (Courts, Psych Services, Depke Juvenile), selected the above providers as the most favorable proposals for Lake County.
