Mumps Outbreak at Barrington High School

The Lake County Health Department is responding to a mumps outbreak at Barrington High School. Thus far, more than 30 confirmed, probable and suspect cases have been reported in the area.

The Health Department is urging parents to keep children home from school and contact their healthcare provider if they experience any of the signs and symptoms of mumps, such as swelling or pain close to the jaw.

The Health Department is working with the Illinois Department of Public Health to organize a vaccination clinic for Barrington High School students and staff who are not up to date with their measles, mumps, rubella (MMR) vaccinations. The clinic will not be open to the general public.

Low-Cost Pet Vaccination Clinic

The Lake County Health Department/Community Health Center's Animal Care and Control Program will be holding their first low-cost vaccination clinic of the season on April 1st at the Beach Park Public Works facility.

The clinic is 9 a.m. to noon and is open to ALL Lake County residents.

Pets are taken on a first-come, first-served basis.

All animals must be at least 4 months old. Dogs must be leashed and cats placed in carriers.

Only cash is accepted at the time of service.

LAKE COUNTY PARTNERS COUNTY BOARD UPDATE MARCH 2017

The Manufacturing Career Expo Taps into Lake County's Young Talent Pipeline More than 350 manufacturing students from the Lake County High Schools Technology Campus participated in a Manufacturing Career Expo on Wednesday, March 8th. The expo gave students the chance to meet with nearly 20 local employers to pursue local job shadow opportunities.

Events like these are especially important because manufacturing plays a vital role in Lake County's economy, with more than seven hundred medical instrument and precision manufacturing and tooling companies operating locally. The industry employs nearly 18,000 people, and jobs within this sector in Lake County are up 15% since 2010 and forecasted to grow an additional four percent by 2020.

The event was jointly sponsored by the school, the Lake County Workforce Development Department and Lake County Partners, and it is one of several that the Workforce Ecosystem partners have recently established to provide Lake County businesses with direct access to talent. Lake County Partners and the Lake County Workforce Development Department will be holding a second expo for students at Waukegan High School in April. Lake County Leads in Alternative Commuters

There is positive news to report on the transportation front in Lake County as it relates to the local workforce. Lake County Partners recently published a data snapshot, which was covered in-depth by the Lake County News-Sun and found that:

- 1. Nearly 25% of Lake County commuters take advantage of alternative transportation modes such as carpooling and commuter rail, resulting in Lake County leading Chicago counties in non-traditional commuters; and,
- 2. Lake County residents are enjoying shorter commutes relative to Cook County counterparts, with nearly 25% of residents travelling less than 15 minutes to work each day. This is largely a result of the fact that nearly 70% of residents both live and work in the county—more than any other suburban county in the region.

Importantly, these trends highlight the need for Lake County government's ongoing investment in transportation infrastructure to meet local demand and ensure a continued high quality of life.
