Project/Activity: Research and develop a list of realistic grant opportunities for such sustainable efforts as

green Infrastructure, 60% Recycling Task Force, energy efficiency, renewable energy, green transportation, etc. and, where directed by County Administrators Office (CAO), assist

departments with grant application process.

Brief Description: Consultant to assist all departments in researching and developing a list of realistically

achievable sustainability grant opportunities. Realistic grant opportunities for such sustainable efforts as green infrastructure, 60% Recycling Task Force, energy efficiency, renewable energy, green transportation, Etc. Consultant shall coordinate departments efforts

in applying for grant opportunities.

Consultant:

Consultant will quickly educate self on the County's current grant processes and practices.

- Consultant will identify and recommend at least eight (8) new, realistic sustainability program
 or project grants, not previously utilized by Lake County. At least two of the eight grants
 should focus on green infrastructure. Examples of previous grants applied for and obtained
 include, but are not limited to, the following: \$144,000.00 ICECF renewable energy
 installation grant; \$9,000.00 State of Illinois Electric Vehicle Rebate Grant; and \$18,000.00
 Grant for 3 EV charging station installations.
- Consultant will coordinate departments efforts in applying for as many identified grants as
 possible. Ideally, grant applications will be submitted for at least five of the eight identified
 grants.
- Consultant will work with the County through the potential grant identification and application process to ensure compliance with all county policies and practices.
- If awarded, consultant will lead individual departments tracking and reporting compliance.

Lake County is seeking a consultant to review our existing Energy Audit and provide a new Energy Audit which includes completed past projects and future energy efficiencies CAO

Strategic Plan Strategy: Brief Description:

Enhance the economic climate and economic readiness of Lake County

The purpose of the Energy Audit is to identify and prioritize energy efficiency projects throughout the County that will produce considerable energy savings, emission reductions, and a reduction of the County's carbon footprint. Each audit will require on-site inspection at various County's facilities. The audit will consist of a general review and analysis of the overall state of the facility pertaining to energy usage, HVAC systems, energy management control systems, lighting, production processes and equipment. Additionally, consideration may be given to effectiveness of windows, insulation, or other weatherization opportunities. The audits will include an analysis of the County's energy usage and costs and compare to other gas and electric utility rate tariffs. Upon completion of an on-site inspection, the vendor shall prepare a written report, which will include a summary of description of the findings or the on-site inspection and specific recommendations for improving energy efficiency for each building. Recommendations for specific projects will include an analysis of the amount of potential energy savings in energy units and dollars, a simple payback analysis and a description of each evaluated energy efficiency measure project with a payback of more than

one year. The vendor will prepare a separate report of each building facility evaluated. At the conclusion of the audit, the vendor will prepare a list of recommended retrofit projects that is prioritized based upon the greatest savings/return on investment and quickest payback. Consultant:

Facilities, Solid Waste Agency of Lake County (SWALCO), Hauling Contractor. Implement long-term solutions for increasing waste diversion through recycling and composting, reducing toxicity of our waste, and developing a long-term disposal option that has a positive impact on energy usage, reducing key pollutants and greenhouse gases. Install a food scrap collection/ waste reduction/diversion pilot program in the jail. If successful, opportunity to roll-out permanently to Jail facility and County commissary operation. Gather information and prepare a full report to CAO on six-month pilot, including metrics and programs operational effectiveness.

- Consultant will work with/lead Sheriff's Office, Facilities, the hauling contractor and SWALCO to identify scope and parameters of plan. Write plan and get its approval from partners.
- Consultant will work with Sheriff's Office to submit plan to accreditation association, if required.
- Consultant will help determine length of pilot program with partners and facilitate implementation of plan with Sheriff, hauling contractor and SWALCO.
- Consultant will manage program during pilot period.
- With cooperation from the Sheriffs' Department, SWALCO and hauling contractor, consultant will establish reporting metrics and gather information on regularly determined basis.
- Consultant will report-out results of data to partners monthly, over the established trial period.
- Consultant will gather information and prepare a full report to CAO on the pilot program, including metrics and programs operational effectiveness.
- Consultant will prepare report on pilot programs results and recommendation (Yes or No) regarding full implementation to the County Board, as directed by the CAO. Report shall include full metrics in waste cost reductions.
