BASED ON THE INFORMATION YOU PROVIDED IN YOUR LETTER OF DECEMBER 1, 2017, WE ARE PLEASED TO ADVISE YOU THAT THE D.A.S. CHARITABLE FUND FOR THE PRESERVATION OF FELINE ANIMAL LIFE HAS APPROVED A GRANT TO LAKE COUNTY TO ASSIST YOUR CANINE UNIT FOR 2018. A CHECK IN THE AMOUNT OF \$25,498.40 IS ENCLOSED. THIS IS A ONE-TIME GRANT AND IS RESTRICTED TO THE ACTIVITIES SPECIFIED IN YOUR PROPOSAL.
