## Scope of Work:

Management Partners shall perform management support services in a satisfactory and proper manner in accordance with direction provided by the County Administrator, or his designee. Management Partners will prepare a Project Plan for each project identified for completion under this agreement, setting forth the details of the planned project including the key work elements and timelines and the time of completion.

#### **BID EXEMPTION RECOMMENDATION:**

Lake County executed a contract with Management Partners, Inc. in May 2017 to facilitate and project manage the Lake County Commission on Government Reform and Accountability. Management Partners, Inc. completed its work for this special commission in January 2018.

The ad hoc committee that reviewed the bid exemption request is recommending Lake County extend its contract with Management Partners, Inc. to continue to perform work through 2018 to support the newly formed Lake County Board Government Reform Implementation Committee. Management Partners, Inc. will provide continuity of this work and bring a wealth of expertise in government reform efforts. We plan to bring a contract to the County Board for approval in March.
