- ANHMP is required to be eligible for FEMA mitigation grant funds



Key Issues for Lake County

- · Moderate-high risk for severe summer storms/flooding
- Increasing rainfall intensities, frequency of flooding, & erosion
- Continue public information activities addressing impacts of natural hazards

ANHMP Recap

- ANHMP is multi-jurisdictional plan required by FEMA & updated every 5 years
- ANHMP examines natural hazards, establishes mitigation goals, evaluates & highlights mitigations activities underway, & recommends mitigation actions for the next 5 years



Flood-Prone Property Buyout Program

- > Acquisition is the most cost-effective mitigation strategy for flooding
 - > Average Benefit-Cost-Ratio (BCR) for acquisitions is 7:1
 - ➤ BCR up from 5:1 reported in 2005¹
- July 2017 Severe Storms & Flood Event:
 - Impacted property owners & residents county-wide
 - ➤ Damaged public facilities & 1000 + structures
 - > IL denied Presidential Major Disaster Declaration

BENEFITS

> FMA & PDM grant applications requesting \$6.5 million dollars to acquire 15 properties county-wide were submitted November 2017



Since 1998, Lake County has received \$15.7 million of grant funding to acquire **220** flood-prone properties

May 2014 vs. July 2017 Storm Events

Larger storm event in 2017 with fewer damaged units


