Status Update

Deputy County Administrator Amy McEwan, noted that the purpose of the meeting is to recruit members to organize member communities and recruit representatives from each community to form the Policy Committee, Operation Committee and sub Committees. A PowerPoint was presented which included a proposed governance structure for the implementation plan. Members were asked to share their ideas and recommendations with the group. Proposed sub committees will be discussed at the next meeting. Main goal is to hire a project manager to lead the Regional 911 Consolidation Implementation Committees.

8.3 18-0548

Proposed governance structure for the implementation plan: Policy Committee (elected officials and managers), Operations Committee (police/fire chiefs and/or other staff), Sub-Committee (staff). Examples of sub-committees could be technology, standard operating procedures, etc.

Deputy County Administrator Amy McEwan noted that everyone's knowledge and feedback is very important in order to have productive work groups. Attendance and participation at each meeting is very important along with sharing the information with the leadership team for your organization including the governing council/board.

8.4 18-0549

Financial management model for the implementation plan.

Expenditures will be approved by the Policy Committee and/or their designee. There may be a need for a smaller Executive Committee to review and approve expenditures in accordance with the prompt payment act.

8.5 18-0550

Intergovernmental agreement and by-laws.

The State's Attorney Office will draft an intergovernmental agreement as far as how funds will be utilized. Operations Committee will review the draft and make a recommendation to the Policy Committee.

8.6 18-0551

Options and process for hiring a project manager.

There are two options for hiring the project manager. Develop a job posting and hire a staff member. This person would be a county staff member until the public safety authority (PSA) and/or other agency is formed. Then the staff can be transferred over to the PSA. A Request for Proposal (RFP) may also be created for the hiring of a project manager to lead the groups. Volunteers to help draft the RFP are needed. Deputy County Administrator Amy McEwan asked that any volunteer interested should contact her directly.

8.7 18-0552

Data collection

Each agency will need to be able to collect data and share in a consistent manner data from their PSAP. The project manager/consultant will assist the group in developing forms to consistently collect and share the data from each agency.
