Chairman Lawlor, noting that a quorum of the Committee is physically present, reported that Member Pedersen will participate in the meeting electronically, in accordance with the County Board Rules of Order and Procedure.

Kevin Knutson, Management Partners, indicated he was tasked to identify the roles the Independent Redistricting Committee could fulfill while preserving the rights and responsibilities of the County Board in the redistricting process.

(Member Mathias arrived at 1:08 p.m.)

Mr. Knutson reviewed the Purpose and Duties section. Chair Lawlor suggested the Illinois Redistricting Collaborative and Change Illinois' Guiding Principles documents be referenced in the Purpose and Duties. He also suggested language emphasizing that public outreach will be coordinated in partnership with the County Board. Discussion ensued regarding the resources needed to be effectual, including staff time and public outreach.

Mr. Knutson reviewed the Membership and Appointments section. Discussion ensued regarding the member selection process. The consensus of the committee was to clarify that the members are not currently elected officials or employees of Lake County government.

Mr. Knutson reviewed the Preparing for Apportionment process section. It was determined

that the legal conforming requirements be identified in this section. Clarification is needed that resources will be provided at the County Board's direction. Discussion ensued regarding the need for milestones and the format in which these milestones will be measured. It was suggested that a section be added identifying the County Board's responsibilities and the selection of members as it relates to this commission.

Mr. Knutson will revise the draft charter for review and consideration at the committee's next meeting.
