Scope of Work:

The scope of this project is to provide the Lake County Sheriff's Office a software product that will print an Illinois e-Citation and Complaint form meeting all guidelines set forth by the Illinois Conference of Chief Circuit Court Judges. Citations are electronically submitted and printed according to AOIC (Issuing Administrative Office of the Illinois Courts) standards and are compliant with the State Uniform Traffic Citation (SUTC).

Deliverables

At a minimum, the selected provider should allow Law Enforcement Officers to create the following types of tickets while in the field:

- Uniform Traffic Summons- as defined by the specifications outlined by the Conference of Chief Circuit Judges; 1 charge per printed tickets, 3 copies printed as required.
- Ordinance Violations
- Allow for multiple drop-down arrest agencies. Default setting should be Lake County Sheriff's Office (LCSO), but will
 require an additional 10 Arresting agencies (the LCSO contracts for policing services with multiple municipalities)
- Allow for multiple court types and locations; i.e. Main courthouse, branch courts, juvenile court, and administrative hearings.
- Provide export capabilities including court case management software, (Circuit Clerk) -the Circuit Clerk has issued an RFP for a new case management system and vendor/system has yet to be selected, LCSO record management system, Tritech, and the Department of Transportation Racial Profiling database.

Evaluation of Proposals:

Evaluation Factors:

- Expressed understanding of and ability to achieve RFP objectives
- Work plan for achieving RFP objectives, including capacity to apply and commit resources necessary to complete required services on a successful and timely basis
- Qualifications of the Proposer and its project team personnel
- Completeness, thoroughness and detail of response (i.e., discussion and coverage of all elements of work listed in the RFP)
- Cost/ Value in relation to the level of service to be provided

Department Recommendation:

Based on the criteria set forth in the Request for Proposal, the review team selected Quicket Solutions, Inc. as the most favorable proposal for Lake County.
