Involve in delivering quality care and positive operating margins within nursing services, surgical and cardiology product lines, performance distinction, case management, and the child care center. - Provided direction which improved ED Physician billing at OLRMC, revenues increased by 5% as diversion hours in the ED decreased by 60% and LWBS (left without being seen) decreased by 15% by implementing different upfront ED processes while improving inpatient throughput
