# 7. President's Report

President Sashko reported on the following:

- 1. Staff did an outstanding job collaborating on the message that was sent out last week in the Ethylene Oxide (EtO) press release as well as the talking points provided to the Board of Health members and County Board members. He thanked Lisa Kritz, Larry Mackey, Hannah Goering, Jefferson McMillan-Wilhoit, and Brian Louie for their excellent work. Mark Pfister met with the Mayors of Gurnee and Waukegan along with their legal council to discuss options for next steps related to IEPA, USEPA and the need for ambient air quality testing. Nothing is definitive at this point and the Board of Health and County Board will be updated as soon as things are finalized. He, Chair Hart, Member Carlson, and Mark Pfister met on Tuesday morning, 2/26, to review where things stand pending next steps and meetings with IEPA. Dr. Ahmed and Larry Mackey are working with the Illinois Academy of Family Physicians on a presentation for primary care physicians on the EtO issue in Lake County.
- 2. He reminded Board Members that their Statement of Economic Interest filing is due and that they should have received an email from the County.
- 3. He had a meeting with Chair Hart this past Monday and they reviewed some of the activities involving the Mental Health Coalition over the past several years. Her focus is developing the resources and partnerships to build a Crisis Drop Off Center through public/private partnerships. He and Mark Pfister have had numerous conversations and provided feedback on the who, how, where and why including the need for greater capacity. Mark is also working on strategies with Gateway to expand behavioral health capacity in Lake County and options of service delivery.
- 4. 2-1-1 continues to develop and Lake County United Way is still evaluating the vendor that would be the call center for operations in the County. They looked at Florida, now California and a couple of others. It is common to hire a third-party provider rather than trying to set up your own call center (much less expensive). Each of the subcommittee workgroups are working on their specific areas of responsibility and making progress.
- 5. He had the opportunity to attend the Governing Council meeting on February 14. They have a new Chair, Melissa Withem-Voss. He and Mark will be meeting with her to look at joint initiatives this year between the Board of Health and Governing Council as we continue to focus on the "one agency" platform. This is also something he discussed with Mallory Bejster during her chairmanship.
- 6. As previously mentioned, Unconscious Bias Training for the Board of Health and the Governing Council is still being looked in to. The option of doing a 90-minute training at RFU followed by a tour of their facility is being considered. More information is to follow once those details are in place.

- 7. Staff Daily Leadership classes occur throughout the year and the next one is May 16 if any of the Board of Health members are interested in seeing what the Health Department leadership team is working on together.
- 8. The Bill for Tobacco 21 (SB 21) is on a third reading in the Senate and there was a minor floor amendment introduced covering the penalties for selling to persons under 21, so it is back to Assignments. It will likely move quickly through its next steps. Since it is in Assignments, it will have to go back to Committee to get back on the floor of the Senate and we may have to slip the bill again in support. It includes all tobacco products with nicotine.
