 Development of a sustainable, implementable plan for improving mobility options for the Lake County region


 Mobility options may benefit other residents, but will focus on the target user groups of older adults, people with disabilities, and individuals with lower incomes


Objectives

- Add new services to address other service gaps


Current Service Area Map
