

## Adult Corrections

Food waste in the prison system is significant:

- -An estimated 200,000 tons of food is wasted in American jails
- -65% of jobs in the green economy are accessible to people with criminal records

## **Short Term Goals**



**EDUCATE** decision-makers on the benefits of composting

COLLABORATE with Lake County Jail, the food service provider Aramark, and the hauler Advanced Disposal (Advanced) to plan and implement pilot systems for reducing waste, recovering food for donation, increasing recycling, and implementing food scrap collection

**DEMONSTRATE** the economic viability of food recovery and composting

## Projected Projected Impact

#### **Environmental Benefits:**

- 495 cubic yards of dining/kitchen materials diverted from landfills each year
- 361.35 cubic yards of food waste composted each year


### **Economic Benefits:**

Lake County estimated annual savings: \$3900


#### **Educational Benefits:**



## Inmate Roles

### All Inmates:

All inmates engage in sustainable practices by

- sorting trash from their trays after each meal,
- using reusable spoons,
- using reusable cups, and
- participating in uniform and shoe recycling.

### Immate Facilities Labor:

Inmates not cleared for work in the kitchen support sorting in the pods monitoring that:

- all garbage is picked off trays and put into a trash bin,
- all food scraps stay on the tray, and
- inmates stack trays in the cart for return to the kitchen.


## Inmate Roles



### **Inmate Kitchen Labor:**

Inmates cleared for kitchen work:

- sort waste that comes back down on the trays to remove any remaining garbage (e.g., condiment wrappers or any other non-compostable material) missed by inmates in the pods,
- tap compostable food waste left on the tray into a compost bin with a compostable liner,
- place trays in the tray dishwasher.










## Lake County Jail Landfill Compactor Service Data 2016-2018

# 34% less trash going to the landfill 350 pounds per day 128,000 pounds per year


#### MONTHLY IMPACT

5.70 tons of material are now being composted and recycled rather than thrown away. That is equal to 5.02 metric tons/month of avoided CO2 emission, or taking 13.01 cars off the road.

#### **ANNUAL IMPACT**

68.40 tons of material are now being composted and recycled rather than thrown away. That is equal to 60.25 metric tons/month of avoided CO2 emission, or taking 156.08 cars off the road.

## **Next Steps - MAINTAIN AND IMPROVE**



implement kitchen recycling

→ identify opportunities to further reduce waste, adjust hauling needs to meet new needs (reduce landfill service)

→ assess inmate sorting in PODS to reduce contamination (trash left on trays)

troubleshoot, identify best practices, report
results

follow up waste assessment



## **Next Steps - ENSURE SUSTAINABILITY**

Follow up with other County departments to:

- adjust food service provider RFP and contract (sorting of food scraps and recycling, reusable spoons, compostable liner bags)
- adjust hauler RFP and contract to include pricing and language related to food scraps, and
- work with facilities to monitor hauler service levels, needs and recycling procedures.
