5.1 18-1488

PY2019 Homeless Assistance Application Round Presentation, Deliberations and Allocations - Discussion and Recommendation

- The Homeless Assistance Advisory and Recommendation Committee (ARC) is responsible for making funding allocation recommendations for the 2019 Emergency Solutions Grant (ESG) funding estimated to be in the amount of \$215,000.
- Recommendations are forwarded for consideration and approval to the Housing & Community Development Commission (HCDC).

Presented by Jodi Gingiss, Community Development Administrator; Eric Foote, Grant Administration Specialist; and Brenda O'Connell, Continuum of Care Program Coordinator, who provided a presentation about the Homeless Coalition and ending Veteran Homelessness.

The funding recommendations were as follows:

Catholic Charities – Rapid Rehousing - \$60,000 Catholic Charities – Homeless Prevention - \$47,500 Lake County Haven – Shelter - \$25,025 A Safe Place - Shelter - \$25,000

PADS Lake County – Shelter - \$23,000

Community Development – HMIS - \$18,350

Community Development – Administration - \$16,125

6. STAFF REPORTS

Jodi Gingiss, Community Development Administrator, informed the ARC members about Community Development's partnership with the Lake County Jail to address the problem of high utilizers of the court and jail systems who are homeless, through the provision of housing and services. Many of these high utilizers have chronic behavioral health issues that need to be addressed. The Corporation for Supportive Housing is providing technical assistance to determine the finances required to expand the Permanent Supportive Housing system, with input from Nicasa, the Health Department and Thresholds as prospective service providers, to help solve this problem. The Pay for Success program could help to fund this expansion by raising upfront capital from foundations and social investors with the capital being provided to the service agencies to allow for the needed increase in services. An evaluator will be hired to determine the program's long-term success, through a combination of each participant's housing status and elimination of jail visits, to reimburse the investors for positive outcomes. It is proposed that any payouts for success will come from the County's Video Gaming Revenue funds.
