Thanks again for meeting me and Paul last week at the project location for Nicor Gas' Trillium Court project. Our construction contractor has verified that we can place the HDD bore pit entirely within uplands, which overlaps the buffer area to the Site 2 wetland. This revised bore pit location is marked in the field with spray paint (see attached photo) and is at least approximately 3 foot outside the wetland boundary.

As we discussed, because impacts to Sites 1 and 2 are being avoided, authorization from the USACE is not required. Nicor Gas plans to update the map of Site 2 to depict wetland boundary as delineated last week, which will be a revision to the LONI for this project. Tom will take care of this submittal to your office to update the LONI.

We should still be on track to complete construction of this Route 22/Trillium Court project before June 1. I appreciate your help in maintaining this schedule.
