PY2019 Affordable Housing Application Round Presentation, Deliberations and Allocations - Discussion and Recommendation

- The Affordable Housing Advisory and Recommendation Committee (ARC) is responsible for making housing-related funding allocation recommendations for the 2019 Community Development Block Grant (CDBG), HOME Investment Partnership and Lake County Affordable Housing Program (LCAHP) funding round.

The funding recommendations, along with Tier 2 funding provisions (see handouts), were presented and discussed, as follows:

Goal 1) Rehab Existing Housing: Affordable and Special Needs

A Safe Place – Security Upgrades - \$51,466 Community Partners for Affordable Housing (CPAH) – Owner-occupied Rehab - \$80,000 CPAH – Community Land Trust Homebuyer Program - \$465,700 CPAH – Community Housing Dev. Organization (CHDO) Operating - \$20,000 DeBruler Co. – Lilac Ledge Senior Apartments - \$637,287 DeBruler Co. – Hebron Townhomes - \$151,940 Raquan's Haven – Home Front Rental Project - \$68,950

Goal 2) Develop New Housing: Affordable and Special Needs

DeBruler Co. – Environmental Assessment for Senior Apartments - \$25,144 Housing Opportunity Dev. Corp. (HODC) – Site Prep for Zion Woods - \$207,442 HODC – CHDO Operating - \$30,000 Youth Conservation Corps – Construction Apprenticeship - \$21,000

Goal 4) Subsidize Housing for Low/Mod Income Families

Catholic Charities – Rapid Rehousing Program - \$50,000 CPAH – Landlord Risk Mitigation Pool - \$160,000 CPAH – Down-payment Assistance Program - \$30,000 Community Development – Proposed RFP for Pay for Success Prog. - \$237,811 A motion was made by Commissioner Swartz, seconded by Commissioner Meehan, to forward the PY2019 Affordable Housing grant recommendations, including the Tier 2 recommendations (see handouts), as presented above, to the Housing and Community Development Commission for approval.
