Beverly Mull, of Scholars Soaring Cultural Center, explained her goal of building the Scholars Soaring Cultural Center in Zion, to be a safe place for families to overcome generational illiteracy. She has a location in mind, which would require demolition and new construction, at a cost of approximately \$4 million dollars. At this point, no other funding has been secured.

Harriet Levy, of the Center for Enriched Living, thanked the HCDC for its support for two previous projects, one of which enabled the Center to incorporate universal design into its building, thereby allowing its developmentally disabled clientele to more easily access services. She also expressed gratitude for a grant to help fund the agency's employment program, which was greatly needed due to the 85% unemployment rate for those with developmental disabilities. The grant helped 15 clients achieve employment, with another 30 individuals working toward employment. She requested that the Commission consider the needs of the disabled when considering the new Consolidated Plan goals, stating that employment is the pathway to inclusion.

Dulce Ortiz, of Mano a Mano, informed the HCDC of her agency's mission, objectives and programs to help immigrants become full participants in life in Lake County, which has recently included reaching out through co-location of services at other public organizations in communities with large immigrant populations. The agency offers programs that assist its clientele gain proficiencies to enable them to obtain employment that will help them along their route to self-sufficiency. She asked the HCDC to consider this population and the agency's programs for inclusion in the 2020 – 2024 Consolidated Plan.

Vice-Chairman Pedersen asked for any questions, to which there was no reply. She then requested a motion to close the Public Hearing.

Joint resolution consenting the transfer of ongoing housing-related commitments from Northpointe Resources, Inc. to Aspire of Illinois.

- Lake County has provided affordable housing grants for the development of affordable rental housing units by Northpointe Resources, many of which carry long-term requirements.
- In order to better serve their clients, Northpointe Resources, Inc., will transfer its assets, employees and programs to Aspire of Illinois, a long standing Illinois not-for-profit corporation recognized as tax-exempt pursuant to Section 501(c)(3) of the Internal Revenue Code, effective August 1, 2019, thereby capturing economies of scale.
- In the attached Consent Letter, NorthPointe requests permission to transfer long-term commitments to Aspire.
- Lake County Housing and Community Development Commission action is requested to recommend Lake County Board review and sign the Consent Letter, which documents the agreement by Lake County, as provider for affordable housing grants and loans for buildings currently owned by Northpointe, for Aspire to perform the Northpointe's commitments.

She said that the experience gained will be leveraged to work toward ending chronic homelessness by the year's end. The HCDC congratulated Brenda with two rounds of applause.
