6.1 19-1734

Commission Action: Issue Call for Key Projects & Proven Programs in Support of 2020-24 Consolidated Plan for the U.S. Department of Housing & Urban Development (HUD)

- The proposed Lake County 2020-24 Consolidated Plan ("ConPlan") for the U.S. Department of Housing & Urban Development (HUD) is focused on achieving the following goals: (1) Improve homeless crisis response system; (2) Assist Persons with Special Needs; (3) Maximize Affordable Housing; and (4) Prioritize Pathways for Economic Mobility.
- These four ConPlan goals face many natural barriers such as historical lack of funding, community resistance and stigma, with 444 square miles of recreational, industrial, and residential land settled in both suburban and urban patterns. To achieve these goals, Lake County is looking for local government and social service agency partners with whom to partner on major strategic projects and proven programs in support of these goals for the next five years.
- Staff requests HCDC approval of the release in tandem of both a Call for Five-Year Strategic ConPlan Projects & Proven Programs and an annual application process. The combination of these two entry points would allow the HCDC to identify potential future recipients of grant funding for strategic projects and proven programs while being responsive to annual community needs. The attached memos detail the two processes.

Trisha Blythe, of Youth Conservation Corps (YCC), thanked the Housing and Community Development Commission (HCDC) for its continued support, explaining that the agency's full-year crew has expanded and continues to learn from their new construction director. YCC will build three affordable homes, to be sold to income-qualified households.

Chris DeBruler, of The DeBruler Company, expressed his company's thanks for the additional funding for the rehabilitation of Lilac Ledge Senior Apartments in Waukegan.

He expects that construction will begin within the next few months.

John Roehlk, Round Lake Heights Chief of Police, attending on behalf of Mayor Lumpkins, thanked the HCDC for the proposed increase in funding for the Village's water main extension project.

Victor Barrera, of the City of North Chicago, informed the HCDC that North Chicago's City Council was excited about the possibility of additional funding for its demolition project, which helps to clear plighted properties. He said that North Chicago looks forward to continuing its partnership with Lake County and to building additional affordable housing.

- The First Amendment to the 2019 Annual Action Plan allocates \$28,681 in new 2019 program income and reallocates \$775,000 from stalled projects.
- Such reallocations require the proposed amendment to the Annual Action Plan be accompanied by a 30-day public comment period and public hearing.
- The Advisory and Recommendation Committees (ARCs) of the Housing and Community Development Commission (HCDC) recommended the replacement projects and programs for funding.
