## Regular Agenda

#### 5.2 19-1997

Defining the role of Lake County Complete Count Committee over the next six months.

The Committee reviewed coverage areas and noted only a small area of Lake County is receiving bilingual census materials but that these materials need to have a larger distribution throughout the county.

Census reporting brings an estimated \$1,400 per person in federal funds annually. There is a need to reassure Lake County residents that there responses are confidential and that they can feel "safe" in responding to the census. Discussion ensued regarding potential ways to market the census including notices in water bills, announcements at committee meetings, representatives discussing at public events. The Committee questioned whether there is an opportunity for the County to help with mailings in mulitple languages.

The Committee reviewed where other 2020 CCCs are located and how best to reach hard-to-count populations.

#### Take aways include:

- requesting that contact information be provided from each community in Lake County by the next meeting.
- distributing a letter to all 2020 CCCs requesting input on what each area is doing to ensure there are no duplication of efforts.
- Homeless Coalition is working with unshletered groups in January.
- Mano a Mano will create a list of safe spaces where residents can self-report. Could food pantries be added to the list of safe spaces and what will they need to be able to provide this service?
- What assistance is needed (funding, equipment, language interpreters) to help CCCs have effective outreach to hard-to-count populations.

Discussion ensued that materials are generally only available in Spanish and in English, but the online form is available in the 12 most common languages. Discussion continued regarding next steps.
