THANK YOU FOR YOUR LETTER OF DECEMBER 1, 2019. AS YOU ARE AWARE, OUR FUND IS LIMITED TO THE PROMOTION AND PRESERVATION OF ANIMAL LIFE IN LAKE COUNTY, ILLINOIS. IN 2019, WE FUNDED OVER 30 DIFFERENT ORGANIZATIONS PROVIDING SERVICES TO ANIMALS IN LAKE COUNTY. ALL OF THOSE ORGANIZATIONS AND TWO NEW ORGANIZATIONS HAVE NOW SUBMITTED REQUESTS FOR 2020 FUNDING AT HIGHER LEVELS. ALTHOUGH ALL OF THE ADDITIONAL PROGRAMS AND EXPENSES APPEAR TO BE WORTHWHILE, WE DO NOT HAVE AVAILABLE RESOURCES TO FUND OUR VARIOUS GRANTEEES AT THE LEVELS THEY HAVE REQUESTED.

BASED ON THE INFORMATION YOU HAVE PROVIDED AND OUR AVAILABLE RESOURCES, PLEASE BE ADVISED THAT THE D.A.S. CHARITABLE FUND FOR THE PRESERVATION OF FELINE ANIMAL LIFE HAS APPROVED A GRANT TO LAKE COUNTY TO ASSIST YOUR CANINE UNIT FOR 2020. A CHECK IN THE AMOUNT OF \$19,800.00 IS ENCLOSED. THIS IS A ONE-TIME GRANT AND IS RESTRICTED TO THE ACTIVITIES SPECIFIED IN YOUR PROPOSAL. UNDER THE TERMS OF THE TRUST THAT SET UP OUR FUND, WE ARE RESTRICTED TO GRANTS FOR THE CARE AND TRAINING OF THE CANINES ONLY AND CANNOT FUND EQUIPMENT, VEHICLES OR POLICE OFFICER SALARIES.
