Adopted in 2018, ON TO 2050 is the comprehensive regional plan for metropolitan Chicago's 8.5 million people across seven counties and 284 municipalities. In developing ON TO 2050, the Chicago Metropolitan Agency for Planning (CMAP) spent three years conducting extensive research, issuing more than two dozen reports, and engaging more than 100,000 residents. ### **Core focus areas**

#### Climate

The impacts of climate change do not affect all residents equally. Vulnerable populations may experience heightened risks, costs, and liabilities, including repetitive flooding, high water rates, and compromised infrastructure in areas that are otherwise overlooked by private investment.

### **Regional economic competitiveness**

Despite our diverse industries, infrastructure assets, well-trained workforce, and strong quality of life, economic and population growth lags behind peer regions. With strengths in business services, transportation, and manufacturing industries—along with a well-educated and globally connected workforce—our region can grow again.

### **Sustainable transportation funding**

The region's transportation system is facing significant challenges. Decades of underinvestment have created a backlog of projects. While the 2019 passage of Rebuild Illinois was a step forward, it did not establish a sustainable funding mechanism. To improve the transportation system, the state must rethink current funding formulas and look for new revenues.

### **Local Technical Assistance projects**


CMAP has conducted more than 20 local planning projects in Lake County since the Local Technical Assistance program began in 2010.

One example of a project currently underway is the Northern Lakeshore Trail Connectivity Plan, which aims to improve walking and bicycling connections between and among the communities of Zion, Winthrop Harbor, Beach Park, Waukegan, and North Chicago. Learn more at: cmap.is/NorthernLakeshore.

### **Transportation projects funded**

CMAP has programed more than \$71 million in federal transportation dollars in Lake County since 2014. These projects have improved access to public transit and bike trails, reduced or eliminated bottlenecks, and increased safety through intersection improvements.
