#### **Outbreak Key Events**

**February 3<sup>rd/4<sup>th</sup>**: CDC guidance on Public Health Management -FDA approved Emergency Use Authorization for testing</sup>

**30<sup>th</sup>**: WHO declared outbreak a Public Health Emergency of International Concern **31<sup>st</sup>**: HHS declare public health emergency in US



#### Global Distribution of Confirmed 2019 Novel Coronavirus



# States with Confirmed Cases of COVID-19




As of February 18, 2020, 15 confirmed cases reported in the United States.



## Coronaviruses

- Virus that comes from a large family of viruses
- Circulates among animals, but can evolve and infect humans (e.g., MERS, SARS, etc.)
- Spreads to an uninfected person when an infected person coughs, sneezes, or talks (within 6 feet); evidence of animalhuman transmission initially
- Causes respiratory illness (fever, cough, shortness of breath)
- Can lead to complication of pneumonia of both lungs

### **Federal Public Health Response**

- Develop public health, healthcare provider, school, and community guidance
- Reduce number of travelers from China
- Travelers from Hubei Province mandatory quarantine for 14-days
- Institute airport screenings
- Isolate, genetically sequence COVID-19 and develop diagnostic testing, reverse transcriptase PCR (rt-PCR)
- FDA approves Emergency Use Authorization for rt-PCR; test now accessible by states and other countries



# **IDPH Response**

- Monitoring global situation
- State preparedness and response activities
- Clinical guidance
  - o HAN's disseminated through SIREN
  - o Assist with evaluation, reporting, testing, case investigation
  - Coordination of diagnostic testing
- LHD guidance
  - o Portal resources
  - Case investigation resources
- Sharing information with state partners and health system partners
- Resources

## Local Public Health Response

- Share information with infection control preventionists and providers for preparedness of hospitals and outpatient clinics
- Developed healthcare checklist describing process of managing a person with symptoms that recently traveled or was in contact with confirmed case
- Update schools regarding guidance for travelers returning from mainland China
- Respond to public, school, and private business inquiries
- Investigate possible Persons Under Investigation (PUIs)
- Developed a Lake County Health Department webpage to update community
- Worked with LCHD-FQHCs to ensure our ability to screen, test and manage PUIs



## LCHD COVID-19 Update

#### Update on PUIs in Lake County

Return travelers from mainland China or contacts to confirmed case:

• Categorized as medium risk to public health:

o Self-monitor symptoms with LCHD supervision for 14 days

 Avoid school/work and other congregate settings and practice social distancing for 14 days

• Categorized as low risk to public health:

o Self-monitor for symptoms

 $_{\rm O}\,\text{No}$  restrictions on mobility



### **LCHD/CHC COVID-19 Preparedness**

- Three highly trained Communicable Disease (CD) staff led by Dr. Ahmed, Medical Epidemiologist (previously with Epidemic Intelligence Service (EIS) at CDC)
- 3.5 additional LCHD staff trained in CD investigation
- Oversight COVID-19 Team formed, twice weekly huddle: Director of Prevention, Director of Health Information & Technology, Emergency Management Program Coordinator, Medical Epidemiologist





### **LCHD/CHC COVID-19 Preparedness**




- Dr. Ahmed in constant contact with IDPH and CDC
- Eight (8) additional LCHD staff trained for potential surge in incoming calls; log-in to phone system to receive those calls
- Forty (40) additional staff ready as surge capacity for contact tracing investigation calls
- Send Word Now set up to immediately notify both groups
- Just-in-time training for callers ready



### **LCHD/CHC COVID-19 Preparedness**

- LCHD CHCs have supplies and are trained on precautions and testing
- Infection Control Kits prepared for individuals being monitored
- New CD On-Call phone; new number disseminated (224-355-5675)
- Additional phones ready to deploy in Board Room, if needed
- Coordinated with Lake County legal system to develop process for involuntary quarantine orders
- Lake County Coroners Office, EMS and Police Chiefs educated on COVID-19





## **General Emergency Preparedness**





- Emergency Operations Center (EOC) ready
- Staff EOC training held January 27, 2020
- MOUs with 17 schools and 11 municipalities for vaccination and/or medication dissemination sites, if needed
- Site general operating manuals prepared
- Potential site manager list updated
- Inventory of supplies

## **General Emergency Preparedness**

Currently:

- Planning training session for potential site managers
- Circling back with schools and municipalities to get current staff names, current inventory of supplies (tables, chairs, etc.)
- Visiting sites for site-specific manuals to be developed and determine potential operation times and process flows
- Reminding schools and municipalities to ensure security plans are updated
