This is new funding that was awarded through State Senator Julie Morrison. The funds will offset some of the costs for the renovation including a medical facility that will be supported by Condell Hospital. There will also be updates with security and the storage room will be turned into a community support group room. The Children Advocacy Center served approximately 1,400 children in 2019 and has a strong partnership with DCFS. Discussion ensued.
