#### **Department Overview**

- Primary functions and tasks
  - Through a five-year community planning process, advises County Board on grants from U.S. Dept. of Housing & Urban Development (HUD)
  - Administers & monitors Video Gaming Revenue Grants
  - Staffs Housing & Community Development Commission
  - Works to further fair housing choice
  - Implements ServicePoint Referral Network
  - Staffs the Lake County Coalition for the Homeless
- Staffing
  - Six grant managers
  - Four homeless assistance coordinators

- Completed gap analysis of Homeless Crisis Response System, allowing use of data to drive decisions
- Developed Lake County Fair Housing Policy Statement (Board Approved December 2019)
- Updated analysis of impediments to fair housing choice containing several Equity and Inclusion action steps for housing
- Consulted with community stakeholders to set four goals for 2020-24 HUD Strategic Plan
