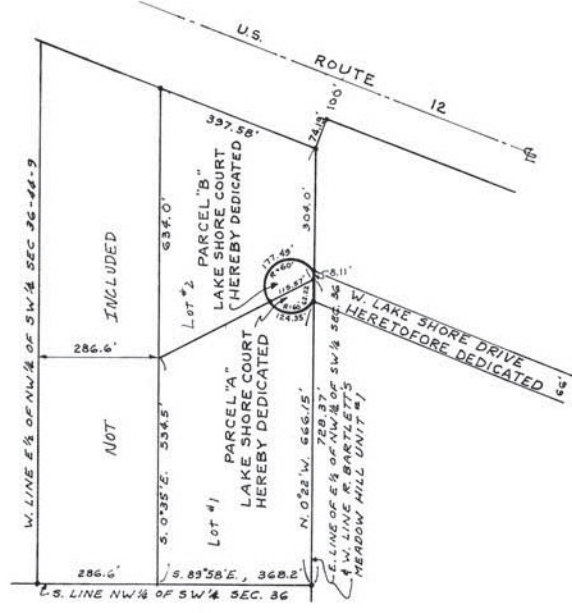


PLAT OF DEDICATION FOR A PUBLIC STREET

PARCEL "A": That part of the East Half of the Northwest Quarter of the Southwest Quarter of Section 36, Township 44 North, Range 9 East of the Third Principal Meridian described as follows: Commencing at the Southeast Corner of said East Half; thence Northerly along the East line of said East Half, 666.15 feet to the Point of Beginning; thence Westerly along a curved line convex to the South and having a radius of 60 feet, an arc distance of 124.35 feet; thence Northeasterly 115.57 feet to the East Line of Said East Half; thence Southerly 62.22 feet to the Point of Beginning. All in Lake County, Illinois.

PARCEL "B": That part of the East Half of the Northwest Quarter of the Southwest Quarter of Section 36, Township 44 North, Range 9 East of the Third Principal Meridian described as follows: Commencing at the Southeast Corner of said East Half; thence Northerly along the East line of said East Half, 728.37 feet to the Point of Beginning; thence continuing Northerly along the last described course, 8.11 feet; thence North and Westerly along a curved line convex to the Northwest and having a radius of 60 feet, an arc distance of 177.43 feet; thence Northeasterly 115.57 feet to the Point of Beginning. All in Lake County, Illinois.
