I am writing to inform you that your program has been selected for funding under the Notice of Funding Opportunity #2115-1302 for the SFY21 Adult Redeploy Illinois program. At the June 12th Adult Redeploy Illinois Oversight Board Meeting, the Site Selection and Monitoring Committee recommended your agency receive up to \$290,801 from Adult Redeploy Illinois Grant Fund SFY21 to implement this program. The Adult Redeploy Illinois Oversight Board approved the Committee's recommendation. The grant agreement number will be provided to you soon.

The awarding of funds for this program is contingent upon SFY21 appropriation level, available funding, the completion of all outstanding requirements, and the execution of the grant agreement.

The documents in the table below are attached and must be completed and submitted to my attention via e-mail no later than June 24, 2020. Please pay close attention to the format in which the documents should be submitted, as submitting the documents in the correct format will help move the process forward.
