Board of Health Report.

Coronavirus Disease 2019 (COVID-19):

The Health Department continues to monitor the ongoing COVID-19 pandemic, assess the needs of our community, and work closely with community partners to address those needs.

As of Monday, June 8, there were 8839 cases and 331 deaths in Lake County.

The Health Department is providing guidance and direct support to all long-term care facilities in Lake County to help prevent cases and slow the spread of infection among this vulnerable population. There are 57 long-term care facilities in the county that have had two or more positive cases, and these facilities have a combined total of 1600 confirmed COVID-19 cases and 228 deaths.

The Health Department has engaged with the State and a local supplier to bring testing capabilities to all long-term care facilities in the county, to assure that residents and staff are tested regularly to identify and control new infections through contact tracing and other mitigation measures.

All Lake County residents and visitors are urged to continue following public health guidelines to prevent the spread of COVID-19. Follow the State guidelines for Phase 3 of the Restore Illinois plan.

Wear a cloth face covering when in public, keep a distance of at least 6 feet from others when outside the home, and frequently wash your hands.

The State's drive-through Community-Based Testing Site has reopened at a new location: 102 W. Water St., Waukegan.

The site is open 7 days a week from 8 a.m. until 4 p.m. or until 750 tests are completed daily.

Testing is free and available to anyone regardless of symptoms.

A name and phone number are required in order to receive testing results.

The Illinois National Guard administers the tests. Results are provided by phone in 4-7 days.

The Health Department has a COVID-19 webpage that includes daily updates, how to protect yourself, what to do if you are sick, information on testing, an interactive data hub, how to get help and ways you can help others. The website is www.lakecountyil.gov/coronavirus.

Racism is a public health issue

Racism is a public health issue, and the Lake County Health Department continues to speak out against the violence, oppression, and injustice faced by our communities of color.

Throughout our country's history, systemic racism has inflicted trauma on generations of Americans due to their skin color, impacting access to quality healthcare, housing, education, healthy foods, and jobs that pay a living wage. These are all key social determinants of health.

Alongside our community partners, our Health Department remains committed to addressing these social determinants of health which are the root causes of poor health outcomes for certain populations.

There is concern that large events such as protests and rallies could lead to a surge in COVID-19 infections, and the Health Department advises anyone who plans to attend such events to wear a face covering, stay 6 feet apart from others as much as possible, and as always, stay home if ill, wash your hands, and cover your coughs and sneezes. The Illinois Department of Public Health (IDPH) is also recommending anyone who has recently been part of these events get tested for COVID-19. IDPH recommends getting tested 5-7 days after attending, or immediately if symptoms develop.

June is Pride Month

The Health Department recently participated in the annual Healthcare Equality Index (HEI) survey of the Human Rights Campaign to seek designation as a Leader in LGBTQ Healthcare Equality.

The survey is used by inpatient and outpatient healthcare organizations nationwide to strengthen the care they give LGBTQ patients.

LGBTQ patients face significant challenges in healthcare: 56% of lesbian, gay, and bisexual people report experiences of serious discrimination in healthcare, while 70% of transgender people report serious discrimination.

The Health Department's Need2Know Lake County program, alongside Human Resources, Communications, and Organizational Development staff worked together to review Health Department policies and practices to align with national recommendations for the submission. Results will be announced later in the summer.

The Health Department offers comprehensive HIV care and prevention including pre-exposure prophylaxis (PrEP), transgender health services, and affirming services for members of the LGBTQ population. Call (847) 377-8450 for more information.

Mental Health First Aid

Due to the COVID-19 pandemic, in-person Mental Health First Aid classes have been suspended in Lake County and across the nation.

The National Council has announced plans to offer Mental Health First Aid classes virtually. The new virtual classes will include a 2-hour self-paced course followed by 4 hours of instructor-led training.

The new online course is based on new curricula, including expanded content on trauma, addiction and self-care.

On a limited basis and by appointment only, Lake County residents can receive low-cost rabies and distemper vaccinations at Lake County Animal Care and Control.
