Brenda O'Connell read the written comments into the minutes, as follows:

Carmen Patlan, of the Highwood Public Library (Library), wrote that the Library extends sincere appreciation to the HCDC for consideration of funding its much-needed vestibule upgrade project, where they hope to provide handicap accessibility to the Library's growing demographic.

Susan Shulman, of the North Suburban Legal Aid Clinic (Clinic), offered thanks to the HCDC for considering the Clinic's application for funding a full-time housing attorney, thereby allowing them to promote the ConPlan goal of ending homelessness. She explained the organization's service area, clientele, services provided and the recent increase in housing-related matters. This increase in calls was due to the pandemic, with an escalation in requests for assistance expected when the moratorium on evictions is lifted. Having access to legal assistance will help low-income households fare better with the legal process and, hopefully, avoid the effects of eviction and homelessness.

Ashley Styx, of Catholic Charities, wrote about the organization's Emergency Assistance Program, thanking the HCDC for its support through the Community Development Block Grant (CDBG) Homeless Prevention funds. She stated that last year the funds allowed them to assist 19 households with obtaining or maintaining stable housing.

Donna Drinka, of Catholic Charities, wrote about the organization's Rapid Re-housing Program, thanking the HCDC for its continued financial support with Emergency Solutions Grant (ESG) funding. This allowed them to serve the most vulnerable households experiencing homelessness and assisting them in securing safe, affordable, permanent housing.

Michael Edgar and Eddie Soto, of the Greater Waukegan Development Coalition (GWDC) and the Lake County Tech Hub (LCTH), wrote about GWDC's mission, growth, strategies and clients. They stated that their fundamental purpose revolves around three activities: supporting and incubating core businesses; pursuing transformative real estate development projects; and facilitating foreign direct investment. They believe that the business support, mentoring program and incubation services that GWDC provides will be in high demand and can help with the unemployment issues caused by the pandemic. They stand ready to aid Lake County.

Beverly Mull, of Scholars Soaring Cultural Center, wrote that she is still in pursuit of the agency's project for the property at 2771 Galilee in Zion.

Samuel DeGrino and Susan Perlman, of Prairie State Legal Services, wrote about their agency's services, the number of clients served during the past year and their funding sources. Further, they state that the services proposed for PY2020 will address three of the four priority needs identified in the 2020 – 2024 Consolidated Plan: ending homelessness, inclusive growth and housing accessibility. Prairie State fosters collaborative relationships with other social service organizations and local government agencies to increase the positive results for its clients. They thanked the HCDC for its support, adding that this funding allows the agency to leverage other state and federal funding for its housing work.

Joint resolution approving 2020 - 2024 Housing and Community Development Consolidated Plan, including the Program Year (PY) 2020 Annual Action Plan (AAP).

- Lake County is the recipient of United States Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) and Emergency Solutions Grant (ESG) entitlement funding.
- As a condition of entitlement funds HUD requires the development and submission of a Housing and Community Development Consolidated Plan (ConPlan).
- The development of the ConPlan includes an updated assessment of affordable housing and community development needs, identification of strategies and goals needed to address the aforementioned needs and the PY 2020 AAP.
- The Program Year 2020 AAP includes annual funding recommendations totaling \$3,118,594 CDBG, \$1,872,154 HOME, \$225,467 ESG and \$301,000 Lake County Affordable Housing Funds.

- In December 2019, Community Development staff received applications for eligible affordable housing programs and projects.
- The available affordable housing funding includes \$301,000 of Lake County Affordable Housing Program (LCAHP) Funds.
- On May 22, 2020, the Affordable Housing Advisory and Recommendation Committee (ARC) voted unanimously to recommend LCAHP funds to the following:
 - Catholic Charities \$150,000 for rapid rehousing;
 - Community Partners for Affordable Housing \$81,000 for the acquisition of an affordable rental housing project;
 - Community Partners for Affordable Housing \$40,000 for the support of housing assistance programs; and
 - o Community Development \$30,000 for grant administration.

7. STAFF REPORTS

Brenda O'Connell presented an update on the COVID Housing Relief Program (CHRP), stating that a program model has been compiled, which includes greater integration with legal advocacy, coordination through ServicePoint and ease of access through the 211 system. Funding now includes additional Lake County Coronavirus Relief Funding of \$4 million for rental assistance and \$1 million for utilities. Implementation of the program is underway. She added that Community Development received approval and contracts from HUD on its Action Plan amendment for the Emergency Solutions Grant Coronavirus (ESG-CV) and Community Development Block Grant Coronavirus (CDBG-CV) funding. Additionally, she said that HUD has announced that Lake County will receive an additional \$1.5 million in ESG-CV2 funding, which is the final installment from the CARES Act.
