## **ESG-CV2 Funding Background**

This ARC meeting will focus on the development of funding recommendations for Lake County's second appropriation of Emergency Solutions Grant (ESG) funding from the Coronavirus Aid, Relief, and Economic Security Act, also known as the CARES Act. This funding is known as ESG-CV2.

Community Development has kept a keen eye on the need to ensure that funding is allocated strategically, reviewing metrics such as the number of people in hotels and other known locations weekly. In addition to sheltering residents, it is crucial to invest in interventions that quickly house individuals and families to maximize safety during this pandemic. It is also important to consider that Lake County's many homeless services organizations are currently operating in an environment where an increase of need due to the COVID-19 pandemic is accompanied by an influx of funding sources. An overview of government resources is below.

Community Development has carefully made the recommendations contained in this memo, considering the availability of other funding sources and the programs that will achieve the most strategic impact. For this ESG-CV2 funding round, the priority has been placed on Rapid Rehousing interventions, which reduces the emergency shelter population and ensures that people can remain safe and healthy in their own homes.
