# DECLARATION OF PERMANENT OPEN SPACE

This Declaration of Permanent Open Space is made this  $23^{-4}$  day of September 2020, by Timothy P. James (the "Grantor").

WHEREAS, Grantor is the sole owner in fee simple of certain real property in Lake County, Illinois, more particularly described in Exhibit A attached here to and incorporated by this reference (the "Property"); and

WHEREAS, the property consists of wetlands, prairie plants, native trees, and open space; and

WHEREAS, as a condition of approval of a Conditional Use Permit for a Planned Unit Development 000536-2019, the area shown and labeled as "Permanent Open Space" in Exhibit A shall be set aside as permanent, protected open space for the purposes of preservation of natural resources; and

WHEREAS, Grantor intends that the Property permanently remain open space;

NOW, THEREFORE, in consideration of the above and the terms contained herein, and pursuant to the laws of Illinois, Grantor hereby voluntarily declares the following:

- (1) The Property, more particularly described in Exhibit A, shall be retained permanently in its natural scenic and open space condition and that any natural plant and animal communities located on the Property shall remain undisturbed with the exception of invasive species removal (i.e. buckthorn), and that no structures or other man-made improvements will be installed upon the Property.
- (2) The property shall be maintained according to the management plan as described in Exhibit B.
- (3) Should a publicly supported, tax-exempt, non-profit organization whose primary purpose is the preservation, protection, or enhancement of land in its natural, scenic, forested, and/or open space condition express interest in accepting a conservation easement which would affect the Property, this Declaration of Permanent Open Space may be revoked and a Grant of Conservation Easement, or similar grant, shall be created and imposed.







# Exhibit B Management plan *Hey and Associates, Inc.*

### INTRODUCTION

This Management Plan (Plan) pertains to the Natural Resource Protection Areas on the project site. The Plan is required by Lake County Planning, Building and Development. This Plan does not include the traditional landscape areas.

### MANAGEMENT

#### REFORESTATION

The planted native trees in the reforestation plan will be maintained and watered as necessary to survive at least one year from the date of installation. Any tree that dies within the first year will be replaced.

#### **BUCKTHORNS**

In Year 1 during construction, the applicant proposes to control the common buckthorn (*Rhamnus cathartica*) and glossy buckthorn (*Frangula alnus*) by cutting and treating the stumps with herbicide. The shrubs will be 1) hauled to an upland location and chipped and/or 2) piled and burned in place during the winter. During the following growing seasons of Years 2 through 5, re-sprouting vegetation, as well as new seedlings, will be treated with herbicide. Persons performing herbicide treatments during the execution of this plan must have a current herbicide applicators/operators license and possess adequate experience in weedy or non-native species identification and management. All herbicides will need to be applied in strict accordance to label restrictions. Management activities shall be by a qualified ecological firm that has experience with vegetation management activities. After the five years are successfully completed, the buckthorn management will be under a long term maintenance plan to be implemented by the property owner.

### NATIVE SEEDING AND PLANTINGS

The native seeding and plantings around Wetland 1/stormwater basin will be subject to a three year management and monitoring plan with annual reports submitted to Lake County Planning Building and Development. Persons performing herbicide treatments during the execution of this plan must have a current herbicide applicators/operators license and possess adequate experience in weedy or non-native species identification and management. All herbicides will need to be applied in strict accordance to label restrictions. Management and monitoring activities shall be by a qualified ecological firm that has experience with vegetation management activities and monitoring protocols. After the three years are successfully completed, the native seeding and plantings will be under a long term maintenance plan to be implemented by the property owner.
